The plan was recommended for Approval:

The agency did not meet all or substantially meet all of its hiring goals at 40%. The promotion goals were met at 52% and the program goals were 100% met(4 of 4).

The Contract Compliance Set-Aside Program for FY 2017/2018 showed 153% achievement for the SBE and 209% achievement for the MBE.

The filing history is as follows: 2015, 2016, and 2017, Approved, 2018, Conditionally Approved, and 2019, Approved.

Health Insurers' Categorization of Certain Gender Confirming Surgeries as Cosmetic Presented by Attorney Michael Roberts and Jonathan Sykes

Following a presentation made by the agency, a motion was made by Commissioner Nicholas Kapoor and seconded by Commissioner Andrew Norton to accept the staff recommendation that the Commissioners *issue a recommendation as presented* with guidance to all such entities as to whether any of their current practices are discriminatory, the scope of the Commission's jurisdiction and authority in this area going forward. The ruling will also direct the inquiry in any public hearing cases which involve these and similar issues. By putting the public on notice through this ruling, if there are instances of noncompliance going forward the Commission can initiate its own complaint.
