Federal and State Context for the Equity Study

The Connecticut General Assembly crafted the Equity Study, in part, to align state efforts with federal efforts to pursue a comprehensive approach to advancing equity within federal agencies.



January 2021

- Executive Order 13985 marks the federal government's creation of a comprehensive approach to advancing equity
- Required United States executive branch agencies and departments to recognize and work to address inequities in their policies and programs
- Key Outcomes:
 - Agency Equity Action Plans
 - Equitable Data Working Group
 - Review Of Equity Assessment Best Practices



June 2021

- Connecticut passed legislation to undertake an Equity Study of executive branch policies and programs
- Commissioned the study to be overseen by the CT Commission on Human Rights and Opportunities (CHRO), in partnership with the Department of Administration (DOA) and the Office of Policy and Management (OPM)
- The Equity Study will inform new state policies, practices, and programs that improve the equity of opportunities and outcomes for Connecticut residents



Equity Study Goals

The Connecticut Equity Study is a multi-phased project that aims to evaluate Connecticut programs and policies for access and outcomes disparities and provide recommendations to remedy those disparities.

How will the Equity Study help Connecticut?

Key Goals

- Evaluate key programs and policies to understand whether underserved communities face systemic barriers to accessing benefits and opportunities via
 - Landscape analysis of equity in state services & programs + expected and actual outcomes for CT residents
 - Review of demographics and outcomes to ID patterns of discrimination, inequality, or outcome disparities for key programs
- 2. Make recommendations to improve those disparities

Key Outcomes

- 1. Contributions to Connecticut's goal of improving data practices across the state
- 2. A review of trends and state progress in addressing known areas of disparity
- 3. Evaluation of the root causes that drive disparities in access and outcomes
- 4. A suggested implementation approach for the recommendations to remedy existing disparities in access and outcomes

Note: The Equity Study excludes review of contracting and procurement practices, as those will be evaluated in the Disparity Study



Key Definitions

Underserved communities:

Populations sharing a particular characteristic, as well as geographic communities, that have been systematically denied a full opportunity to participate in aspects of economic, social and civic life, such as Black, Latino, and Indigenous and Native American persons; Asian Americans and Pacific Islander and other persons of color; members of religious minorities; lesbian, gay, bisexual, transgender and queer persons; persons with disabilities; persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality



Process and Timeline

The Connecticut Equity Study will be conducted over 11 months and divided into phases including data collection and analysis, recommendation synthesis, and production of a final report and implementation.

Opportunities for Public Engagement

CBO Focus Groups & Connecticut Resident Focus Groups Focus groups will be a key part of the Equity Study data collection process. Focus groups will ask community organizations and residents about their experiences with Connecticut agency programs and policies.



Public Survey

A public survey will be open throughout the duration of the Equity Study. All Connecticut Residents are encouraged to provide any relevant insight, personal experience, feedback, or recommendations at any point through the public survey while the Equity Study is underway.



Listening Tour

Feedback on the initial report and implementation plan will be collected through a series of public meetings that Connecticut residents are encouraged to attend. Collected feedback will be incorporated into the final report delivered to the State of Connecticut.
