## I. Welcome and Introduction

The meeting was called to order by Co-chairman Lt. Gov. Michael Fedele at 1:10 PM. Lt. Gov. Fedele welcomed and thanked everyone for attending the CJIS Governing Board Special Session.

# II. CJIS Governing Board, Executive Director

Lt. Gov. Fedele stated at the July 31, 2008 regularly scheduled CJIS Governing Board meeting, it was discussed that the CJIS Governing Board Executive Director Search Committee had chosen three prospective candidates for the CJIS Governing Board Executive Director position. In addition, Lt. Gov. Fedele gave a synopsis of the search process for the Executive Director. At the time of the July 31, 2008 meeting, the Search Committee had not yet completed the background checks on each prospective candidate. Lt. Gov. Fedele, Judge Patrick Carroll and Undersecretary Brian Austin were reviewing the background checks of each candidate. Lt. Gov. Fedele suggested at the July 31, 2008 meeting, that a Special Session will be held for the CJIS Governing Board Executive Director position, when the background check process was completed and the Search Committee had further opportunity to meet to receive reports on the background checks. At this Special Session, the CJIS Governing Board members would then consider the candidate recommendation from the Search Committee. Fedele's office on August 14, 2008 to consider the additional background check information and recommend candidate for the Executive Director position. Lt. Gov. Fedele opened the floor for any comments concerning the recommendation. Senator Andrew McDonald asked to address the CJIS Governing Board members about the recommendation of Mr. Thakkar.

Lt. Gov. Fedele asked that the CJIS Governing Board enter into Executive Session for the purpose of discussing the employment recommendation of Mr. Thakkar. By consensus and without objection of the members of the CJIS Governing Board who were present, the CJIS Governing Board went into Executive Session. Lt. Gov. Fedele asked members of the public to exit the room.

## **III. Executive Session:**

The Executive Session began at 1:25 PM.

The Executive Session went into recess at 2:05 PM in order for Designee Deborah DelPrete Sullivan to communicate with and bring Chief Public Defender Susan Storey of the Office of the Chief Public Defender Services up to date with the proceedings of the CJIS Governing Board Executive Session. The Executive Session resumed again at 2:15 PM.

Executive Session ended at 2:30 PM, Lt. Gov. Fedele invited members of the public to return to the room to resume the CJIS Governing Board meeting.

## IV. Vote to Approve Recommendation:

Lt. Gov. Fedele called the CJIS Governing Board back to order. Lt. Gov. Fedele requested a vote by all members present to accept the CJIS Executive Director Search Committee's recommendation of Mr. Sean Thakkar, under the conditions that he accept the negotiated salary offer provided releases from all applicable non-competitive agreements from previous employers are obtained. A provision to the vote will be if Mr. Thakkar does not accept the proposed offer, Mr. Jason Rosado will be offered the position with the same stipulation. The CJIS Governing Board voted eleven in favor, two not in favor, and one abstention, to accept Mr. Thakkar for the CJIS Executive Director position.
