 - Fifty-six departments are connected to the state network





CISS Project Update Change Control #60

- Build five new Information Exchanges for Release 4
- Change responsibility from Xerox to CJIS IT for the five Information Exchanges in Release 8: Pardon Notice
- Extends the timeline for Release 4 and subsequent release dates, however overall project end date remains the same
- The Change Control solution was approved by stakeholders and reviewed by the CJIS Governance Committee

CJIS Hosting

 Centralization of shared applications using the CJIS infrastructure

Overview

- Record Management System (RMS)
- RMS owned by CRCOG and CPCA

Advantages

- Centralized RMS
- Significant cost savings for municipalities
- Facilitates data sharing



CJIS NDA

 Approve the CJIS Non Disclosure Agreement (NDA) for state and municipal employees, consultants and vendors obtaining data for the CT Criminal Justice Information System (CJIS) projects, including, but not limited to, CISS, CIDRIS, and OBTS.

CJIS Organization Reporting

- Revisit the discussion on the approach and direction for a Memorandum of Understanding (MoU) that describes the agreement to move CJIS from OPM to DESPP for Administrative Purposes Only (APO).

- Seek board approval to continue development of operational MoU.






Reporting Period 3/1/15 - 6/10/15

- There were no areas perceived as weak, or below 2.5 (a first)






Project Group Scores by Report Quarter



Project Health Check Risks

- 1. The potential move of CJIS from OPM to DESPP for APO offers many possible benefits and risks.
- 2. Stakeholder agencies will not agree on an outstanding parking lot issues, stalling the project.
- 3. A significant number of CJIS Project Management staff continue to leave the project.
- 4. The eighteen unfilled state full time employee positions for the project are not being filled in a timely manner.
