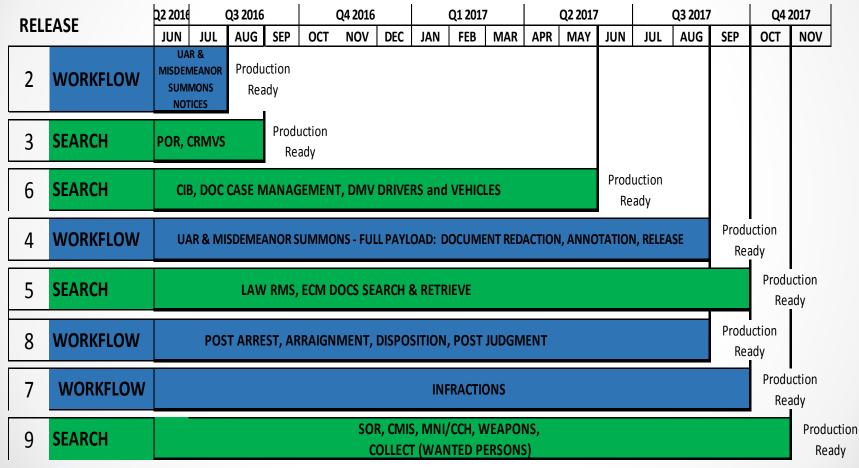

### **PSDN Network Connectivity**

# Hosting CT: CHIEF Pilot

Wethersfield PD status on CT: Chief

- 50% officers trained and using CT:CHIEF
- 80% data converted
- Fully converted & trained by the end of September
- To date no incident support tickets have been opened for CJIS
- Storage usage is well below forecast

## **DCJ SharePoint**

- Request from the Division of Criminal Justice (DCJ).
  - Host their SharePoint site utilizing the CJIS external facing SharePoint server for a large Homicide case
- Opportunities:
  - Use existing resources from CJIS
  - CJIS partners to collaborate on CJIS data for a critical investigation that would otherwise not be possible
  - Collects information for future CJIS SharePoint use.
  - "Do more with less"
- UPDATE Now in Production



### **High Level Strategy**

- Synchronize adding users to CISS Search value
- Complete end to end connectivity to CISS for all CJIS agencies
- Work with each agency to identify prioritized list of administrators, users and an agreed upon schedule
- Train users and provide secure access to CISS Search

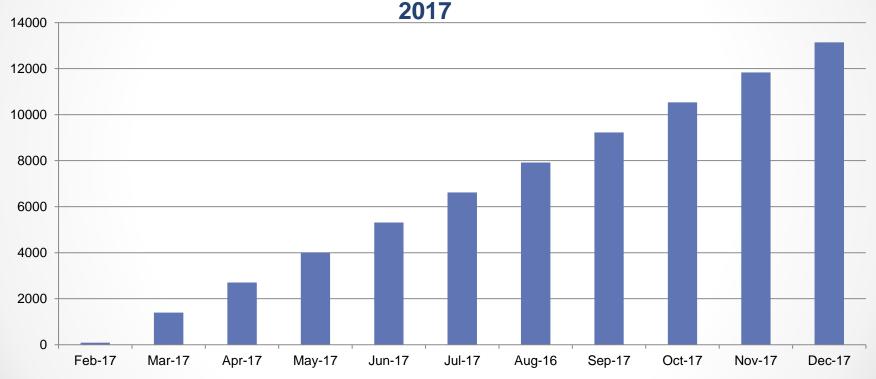

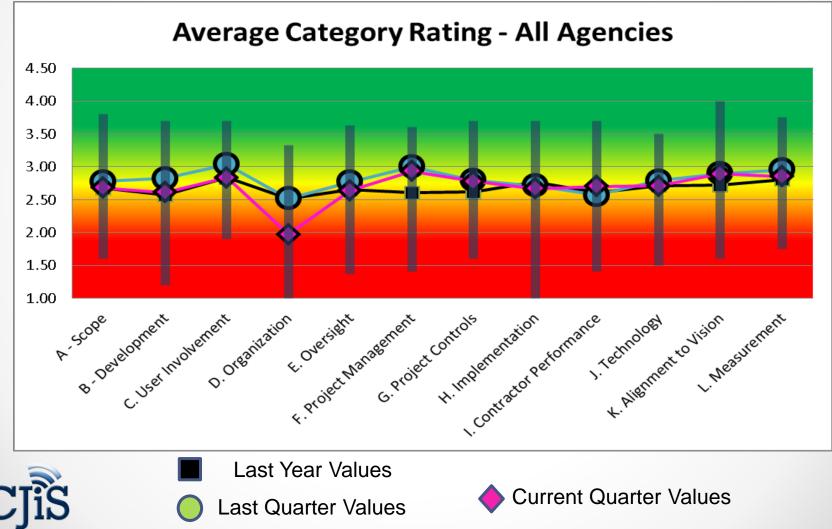

### It Finally Happened.....

As anticipated, survey scores decreased this quarter. Contractor Performance was the lone category to increase. Survey questions related to resources or project timeline dragged scores down. The overall project score decreased from 2.81 to 2.69. If Agencies' resources are impacted more than expected, the scores will likely decrease further in the coming quarter.

Until all decisions from the budget cuts are known, including court closures and State-wide "bumping", Stakeholders will be unsure if they can meet project demands in the current timeline. It will be essential for the PMO to work closely with Agencies to plan resource needs as far ahead as possible to ensure the project schedule is not impacted.



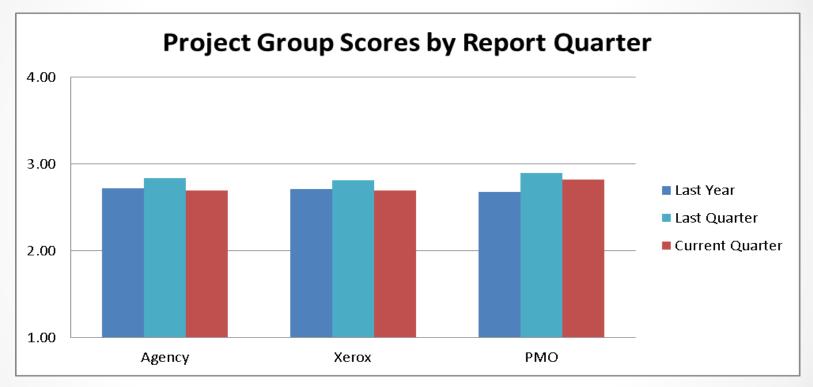


- Contractor Performance was the sole category to increase this quarter. The PMO worked with Agencies and Xerox this past quarter to improve the requirement gathering sessions. The efforts appear to be paying off, as Stakeholders noted improvements in this area.
- Project Management decreased slightly but remains high. It is important that this category is perceived as a strength as the project navigates the State budget situation.
- User involvement decreased this quarter but remains fairly high. Additional cuts will likely mean further decreases in this score in future quarters.



- Stakeholders are still concerned about the timeline. With fewer resources at their disposal, it will likely be difficult for Agencies to meet some CISS timelines.
- In summary and at a high level, the looming budget cuts were the leading cause for the decrease this quarter.





- AGENCY As with last quarter, the biggest concern Agencies had this quarter was resource availability for the rest of the project
- XEROX Agencies noted improvements in the requirement gathering process this quarter
- PMO The Project Management category score decreased this quarter from 3.00 to 2.94, however, it is the highest rated category

### **Key Risks**

 Again this quarter the State budget cuts influenced interviews and survey responses. At the time of the interviews and surveys, some Agencies had initiated resource cuts in anticipation of future budget reductions, while other Agencies were awaiting final details

On the positive side, many Agencies continue to note their commitment to the success of this project and stress the long term efficiency gains most Agencies hope to receive when the project is fully implemented.

### Key Risks

- Risk #1 Stakeholder Agency(s) will not agree on an outstanding parking lot issues (like data sharing and security), stalling the project
- Risk #5 The eighteen State positions needed to operationally support the system
- Risk # 9 The cross-agency support systems, policies, and procedures needed to be in place to support various release implementations
- Risk #11 State budget cuts impact project resource availability, either directly or indirectly, including the prolonged impact of "bumping"
