1. Welcome

Criminal Justice Information System (CJIS-CT) Governing Board Co-Chair, Judge Patrick Carroll, called the meeting to order at 10:01 AM to welcome all attendees. CJIS-CT Executive Director, James McGennis, welcomed and thanked all attendees to the meeting. He emphasized the importance of collaboration for projects like CISS and acknowledged the critical guidance and oversight provided by the committee. McGennis acknowledged the upcoming National Correctional Officers Week and National Police Week, highlighting the contributions of the criminal justice community. He then suggested the meeting to start with Other Business topics to permit maximum time for discussion.

2. Approval of Minutes from April 12, 2024

Judge Carroll made a motion to approve the minutes. There were no other comments. Therefore, previous Governance Committee meeting minutes held April 12, 2024, were unanimously approved.

3. CJIS-CT Business

a. CISS Workflow Status Updates – Integration Testing with Both State Agencies and RMS Vendors RMS

CJIS-CT Senior Project Manager, Chris Lovell, presented updates on CISS Workflow deployment and integration efforts with RMS vendors, sharing key numbers with the attendees. He mentioned integrating with 105 police entities, including state police barracks, which was an increase from the original 93 entities. Lovell highlighted the consolidation in the market, with RMS vendor NexGen serving 74 police departments and 11 state police barracks. It was noted that 62 NexGen police departments are now fully prepared for the arrest package functionality. Lovell identified ongoing efforts to address integration challenges with non-NexGen RMS used in larger cities. Additionally, the complexities of integration testing with various stakeholders were acknowledged, with efforts underway to refine these processes for a successful statewide deployment. The Committee raised several key points during the discussion, including:

- Deputy Chief State's Attorney, John Russotto, sought clarification on non-NexGen RMS vendors, particularly in large cities like Hartford, Stamford, Milford, and New Haven. Lovell noted that due to the volume of arrests packages coming in from these vendors, it is important to integrate with them. CJIS-CT Program Manager, Mark Tezaris, also shared that CJIS-CT has received additional funding from OPM to bring on another large vendor and are in the process of communicating with the vendor while also working on a cost-benefit analysis proposal to be shared with the committee for review and input.
- DCJ IT Director, Naveen Prathikantam, encouraged considering alternative
 vendors for the CISS Workflows, emphasizing the benefits of an inclusive
 approach. He highlighted the potential advantages of integrating with other RMS
 vendors and stressed the importance of analyzing market data for informed vendor
 selection decisions. Prathikantam emphasized the need for creating a roadmap for
 new vendor integration and fostering collaboration for system enhancements.
- CIO Mark Raymond emphasized the importance of maintaining fairness and transparency when selecting vendors, highlighting a structured and unbiased approach to vendor management to uphold the integrity of the selection process.
 Similarly, Judge Carroll underlined the significance of setting clear guidelines and

- equal opportunities for all vendors to participate in the project, promoting a level playing field for vendor selection.
- James McGennis provided a link to the CJIS-CT website that includes resources for RMS Vendors to become CISS Certified in compliance with PA 23-36.

b. Grant Funded Work - Updates

- James McGennis shared that CJIS-CT received a federal Edward Byrne Memorial
 Justice Assistance Grant (JAG) for purchasing new routers to replace end-of-life
 routers at the municipal Police Department. Funding for this project was allotted
 from OPM, and an MOU agreement between CJIS-CT, DAS BITS, and DESPP
 was being finalized. More details to follow in future reports.
- He also shared that CJIS-CT was reviewing a National Criminal History
 Improvement Program grant opportunity with OPM for a potential future project
 involving CISS Search integration with the Deadly Weapons Offender Registry.
 An MOU with DESPP for information exchange agreement was being finalized.
 The goal of this grant would be to cover the integration costs for the CISS team.
- Additionally, CJIS-CT and DOC are reviewing a granting opportunity with the Urban Institute to evaluate the impact of HB No. 7104 (reduced penalties for felony drug possession crimes to a Class A misdemeanor). The Urban Institute is looking for a statement of interest from DOC and CJIS-CT, followed by a proposal to support this granting activity with data. McGennis reached out to Undersecretary Daniel Karpowitz to coordinate with OPM and the Criminal Justice Policy and Planning Committee to align on how to respond to the request. Undersecretary Karpowitz sought more information on the methodology, and he and McGennis plan to have a conversation with the Urban Institute in the future.

c. Digital Evidence Study – Updates

 McGennis noted that discussions were underway with OPM regarding the funding needed for the project's Phase One. Additionally, potential chargeback models for municipal PDs were being considered for those utilizing the centralized state tool. McGennis mentioned that the report's conclusion would be shared in a future meeting once these activities were completed.

4. Open Discussion

No other items were raised.

5. Risk and Issues

Prior to the meeting, a <u>full documents package</u> including a comprehensive Risks and Issues Register was distributed to the Committee. The highlighted risks and issues below were brought forward for discussion to the Governance Committee, **highlighting only those that generated discussion**:

- 1. Key Risk #1 RMS Vendor Participation Does Not Provide 90% + of All Arrests to CISS
 - No discussion items
- 2. Key Risk #2 System Reliability/Up-time not Meeting 99.9% Requirement
 - CIO Mark Raymond inquired about the timeline for the implementation plan.
 Tezaris indicated that a timeline for a phase one plan is to be completed by the
 end of the year, with CJIS-CT Operations Manager, Archana Mulay, serving as
 the project manager. He emphasized the importance of clear and concise
 reporting that caters to a broad audience, ensuring comprehension for
 everyone, not just those with technical expertise.
- 3. Key Risk #3 Two new RMS vendors are required to onboard into CISS Workflow. Adding these two RMS Systems will bring at least 90% of the arrest information into CISS as planned. The challenge lies with cross-branch/cross agency resource capacity to support the onboarding. This work will require resources and hence agency funding will be required for each new vendor integrated into CISS.
 - No discussion items
- 4. Issue #1 Source Systems Not Available to CISS Search
 - Cynthia Powell raised concerns about access to the WANTED database, which
 is classified as federal information, shared in the CJIS-CT system. She
 highlighted the importance of proper vetting of individuals who have access to
 sensitive information through the CSO.
 - Nicole Lake shared insights on the formal request sent to the Attorney
 General's Office for an interpretation regarding WEAPONS data sharing to the
 data feed in CISS. She mentioned that the request was under review by the
 Solicitor General to provide clarity on what information can be shared and in
 what manner. Lake highlighted the importance of seeking formal opinions to
 navigate the complexities of WEAPONS data sharing and access within the
 organization.
 - In response to the concerns raised about proper vetting, Mark Tezaris clarified that CJIS-CT personnel underwent thorough vetting at the project's outset. This included background checks required by both DESPP and the FBI, ensuring all individuals meet the necessary security standards.
 - CSO Glory Bulkley acknowledged the importance of seeking formal opinions
 from the Attorney General's Office to clarify data sharing practices within the
 CJIS-CT system. Bulkley expressed the need for a larger conversation to
 address concerns related to accessing federal information and the vetting
 process for individuals with access to sensitive data. She suggested scheduling
 a meeting with Cynthia, Nicole, and CJIS-CT staff to delve deeper into the
 topic and find a resolution.
 - Additionally, Bulkley highlighted DESPP's commitment to collaboration and partnership with CISS at the DESPP headquarters for testing and accessing the

two terminals, emphasizing the significance of clear communication and cooperation among team members.

6. Action Items

1. <u>Meeting between CJIS-CT/DESPP:</u> CJIS-CT will convene a meeting with DESPP to further discuss and clarify concerns about accessing WANTED and WEAPONS data and define the vetting process for individuals with access to sensitive data.
