Thanks, David. I'm glad you asked this question. It is a good lead-in to future proceedings held on this matter.

As we briefly discussed during the pre-hearing conference, would any counsel of record object to continuing the proceedings for this matter remotely beyond the expiration of the Governor's orders, subject to any substitute legislation, orders, etc. and/or based on the fact that the application was received when the Governor's orders relative to remote proceedings were in effect?

We received notice yesterday afternoon that although our office building is open, all occupants are still required to wear masks in all common areas and exercise 6-foot social distancing even though the gathering capacity restrictions are lifted. It doesn't matter if you are vaccinated. For those of you who have been in our hearing rooms, I don't know how we could accomplish the social distancing among the Council members let alone the parties, witnesses and public. As for the mask wearing, transcription will also likely be challenging.

Please let me know if there are any objections or if there is a preference for a formal memo to be issued on the topic.
