#### I. Introduction

The application is from Arx Wireless Infrastructure, LLC for the construction, maintenance, and operation of a telecommunications facility and associated equipment in the City of Milford, Connecticut. It identifies Cellco Partnership d/b/a Verizon Wireless and New Cingular Wireless PCS, LLC d/b/a AT&T as the anchor tenants.

### II. Technical

The application conforms to the Council's *Application Guide for Community Antenna Television and Telecommunication Facilities* dated July 2012, includes relevant maps, descriptions of the site, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. This project would not require an outside consultant.

#### III. Administrative Review

All service and filing requirements pursuant to Connecticut General Statutes (CGS) § 16-50*l* (b) have been fulfilled. Notice to the general public was published in the <u>New Haven Register</u>.

## IV. Procedural

Pursuant to CGS §16-50m, the Council must schedule a public hearing not less than 30 days and no more than 150 days after receipt of an application. At least one public hearing session shall be held after 6:30 PM for the convenience of the general public. The Council must also designate a place for the deposition of the transcript. In accordance with CGS §16-50m and Governor Lamont's March 14, 2020 Executive Order No. 7B, as extended, staff recommends holding a remote public hearing via Zoom conferencing on June 15, 2021 and depositing the transcript in Milford City Hall.
