The Connecticut Siting Council (Council) is in receipt of the request for an extension of construction time in the above-referenced matter dated December 19, 2022. Pursuant to Condition No. 7 of the Certificate issued on August 27, 2021, the Council hereby grants your request for an extension of time to complete the construction of this facility until February 27, 2024.

Pursuant to Condition Nos. 7 and 8 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.

Dear Executive Director Bachman:

This letter is respectfully submitted on behalf of our client, New Cingular Wireless PCS, LLC (“AT&T”), in connection with the captioned Facility for which the Siting Council issued a Certificate of Environmental Compatibility and Public Need to New Cingular Wireless PCS, LLC in Docket 501 (“Certificate”).

Condition 7 of the Decision and Order dated August 23, 2021 required the approved facility to be fully constructed and providing wireless services within eighteen months from the date of the mailing of the Council’s Findings of Fact, Opinion, and Decision and Order, or by February 23, 2023.

AT&T obtained a building permit for the approved Facility and is currently working with Eversource to finalize and execute a utility easement for the project, which is required before construction can commence. In addition, AT&T agreed to avoid construction during the inn’s busy season. Given these circumstances, AT&T respectfully requests a one-year extension to February 23, 2024. In accordance with condition 11 of the Decision and Order, notification will be provided regarding the commencement of construction activities.
