1. I am over eighteen years of age and I understand the obligations of a statement under oath.
2. I am a Project Manager for All-Points Technology Corp., P.C. ("APT").
3. APT has been working closely with the Docket No. 502 applicant, Cellco Partnership d/b/a Verizon Wireless in its application to establish a wireless telecommunications facility at 118 Newton Road, Woodbridge, Connecticut (the "Site").
4. Under my direction and supervision, New Haven Sign Company was responsible for the posting of the "Public Notice Sign" at the Site.
5. In accordance with Connecticut Siting Council ("Council") guidelines, a public notice sign is posted along Newton Road, in front of the subject parcel at 118 Newton Road.
6. A second public notice sign is installed near the proposed site access driveway off Soundview Drive.
