### **Continuation of Evidentiary Hearing**

The Connecticut Siting Council (Council) shall continue the evidentiary hearing for the above-referenced proceeding on Thursday, September 2, 2021, via Zoom conferencing, beginning at **2:00 p.m**. A copy of the Instructions for Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the appearance of the Applicant for cross examination on new exhibits by the Council, AT&T and City of New Britain (City) followed by the appearance of AT&T for cross examination by the Council, Applicant and City and thereafter with the appearance of the City for cross-examination by the Council, Applicant, and AT&T.

#### **AT&T Late-Filed Exhibits**

During the July 20, 2021 evidentiary hearing session, the Council requested that **AT&T** submit the following information as late-filed exhibits:

- 1. Provide the sum of the existing 700 MHz secondary roadway coverage gaps that are associated with 3.9 miles of proposed incremental secondary road coverage noted on page 4 of the Radio Frequency Analysis Report under Tab E of the Application;
- 2. Explain why the proposed facility would not fully cover the area to the east in the vicinity of Eddy Glover Boulevard; and
- 3. Explain if a telecommunications facility at 52 Derby Street, New Britain would meet AT&T's wireless service objectives or not.

The Council requests these late-filed exhibits be submitted to the Council before the close of business on **August 26, 2021**.

To save the time and expense of the parties, intervenors and the public, and to conclude this proceeding in a timely fashion, the Council requests that all parties and intervenors submit additional interrogatories to the applicant and other parties and intervenors on or before **August 19, 2021**. Interrogatory responses and additional pre-filed testimony, as well as any supplemental information requested from the applicant during the July 20, 2021, should be submitted to the Council on or before **August 26, 2021**.

Any request for an extension of time to submit pre-filed testimony and responses to interrogatories shall be submitted to the Council in writing pursuant to §16-50j-22a of the Regulations of Connecticut State Agencies.
