## Docket No. 505 Development & Management (D&M) Plan Interrogatories – Set 2

- 11. Referencing the response to Interrogatory 7c, the Toxicity Characteristic Leaching Procedure (TCLP) test results indicate the selected solar panels will be considered hazardous waste at the time of disposal, under current testing criteria. Specifically, the result for lead (10.3 mg/L) exceeds the State and Federal Regulatory Level of 5.0 mg/L. Submit TCLP results for solar panels to be used for the project that meet TCLP regulatory criteria, in accordance with the Council's Findings of Fact No. 128.
- 12. Referencing D&M Plan Sheet T-02, construction hours are listed as 6:30 a.m. to 3:30 p.m. Monday-Friday. The Council's Findings of Fact No. 116 listed construction hours as 7:00 a.m. to 5:00 pm. Monday through Saturday. Clarify.
- 13. Referencing the Spill Response and Control Plan in D&M Plan Attachment 7 -Health and Safety Plan, and Site Plan GN-2, provide contact information for the spill response contractor and the DEEP Spill Emergency Response Unit.
