Good morning, Attorney Fisher.

Thank you for submission of the late-filed exhibits requested by the Council for Docket 506.

Given Attachment 1 to the Supplemental Submission is a Request to Initiate a Feasibility Proceeding pursuant to Connecticut General Statutes §16-50aa(c)(2), the Council must initiate a feasibility proceeding and must schedule a public hearing on the request within 90 days of receipt. This is not discretionary under the statute. The Council must also provide notice of the hearing to the owner of the facility, the requesting entity and the municipality where the facility is located not later than 30 days preceding the hearing. A schedule will be developed and placed on the Council's January 13, 2022 regular meeting for approval of the feasibility proceeding schedule.

In the meantime, given that a feasibility proceeding has been commenced by AT&T as of December 14, 2021 that is separate and distinct from the proceedings on the application in Docket 506, if Mr. Bartolotta plans to appear as a witness in Docket 506, the City will be named as a party to Docket 506 and Mr. Bartolotta will be listed as the City representative absent any written submission from the City indicating otherwise.
