Motions

During a public hearing of the Connecticut Siting Council (Council) held on December 21, 2021, the Council ruled on the following requests:

a. City of Middletown (City) Request for Party Status, dated December 15, 2021. The request for party status was granted.

b. Talias Trail (Joseph Barbagallo, Kelly Pugliares and Michael Siteman) Request for Party Status, dated December 20, 2021.

The request for party status was granted.

Continuation of Evidentiary Hearing

The Council shall continue the evidentiary hearing for the above-referenced proceeding on **Thursday, February 3, 2022,** via Zoom conferencing, beginning at **2:00 p.m**. A copy of the Instructions for Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the appearance of Talias Trail for cross examination by the Council, Applicant and City, to be followed by the appearance of the Applicant for cross examination on the new exhibits by the Council, City and Talias Trail.

Applicant's Late-Filed Exhibits

During the December 21, 2021 evidentiary hearing, the Council requested that AT&T submit the following information as late-filed exhibits:

- a) Provide a cost estimate of the small cell configuration described in Late Filed Exhibit a;
- b) Provide the run time for the proposed diesel generator based on its fuel capacity and operating at full load conditions;
- c) Determine if natural gas is available at the site; and

d) Identify any alternative site(s) (other than the Lawrence School property at Kaplan Drive) that were evaluated by AT&T, and provide the reason(s) such site(s) were rejected.

The Council requests the late-filed exhibits be submitted to the Council before the close of business on **January 27, 2022**.

To save the time and expense of the parties and the public, and to conclude this proceeding in a timely fashion, additional interrogatories should be exchanged among the parties on or before **January 20, 2022**. Additional pre-filed testimony and responses to interrogatories should be submitted to the Council on or before **January 27, 2022**. A revised schedule is attached.

Any request for an extension of time to submit pre-filed testimony, responses to interrogatories or late-filed exhibits shall be submitted to the Council in writing pursuant to §16-50j-22a of the Regulations of Connecticut State Agencies.
