Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about January 27, 2022 by Homeland Towers and Celco Partnership d/b/a Verizon Wireless (the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility on an approximately 7.86-acre parcel at 222 Clintonville Road in North Branford, Connecticut. The Applicant proposes to construct a 110-foot monopine tree tower in the easterly portion of this parcel. Access to the facility compound will extend from Clintonville Road over a new gravel access driveway. Celco will install antennas and remote radio heads at the 96-foot level on the tower. Municipal and emergency service antennas will extend off the top of the tower. Radio equipment cabinets for Celco and the Town, a battery cabinet, a propane generator and a 500-gallon propane fuel tank will be located within a fenced compound near the base of the tower. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.
