The Connecticut Siting Council (Council) is in receipt of your correspondence dated February 6, 2023 regarding the revision to the Development and Management (D&M) Plan for the above-referenced facility that was approved by the Council on October 13, 2022.

Pursuant to Regulations of Connecticut State Agencies (RCSA) §16-50j-77(b), your request to revise the approved construction hours from 8:00 AM to 5:00 PM Monday through Friday to 7:30 AM to 5:30 PM Monday through Friday is hereby approved. The revised construction hours are within the Town of North Branford's noise standard for construction hours of 7:00 AM to 9:00 PM.

This approval applies only to the D&M Plan Revision dated February 6, 2023.

Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to RCSA §16-50j-77.

Please be advised that deviations from the Council's May 26, 2022 Decision and Order and October 13, 2022 D&M Plan approval are enforceable under the provisions of Connecticut General Statutes § 16-50u.
