3. Under my direction and supervision, five notice signs were posted at:

- the West River Substation located at 255 Ella T. Grasso Blvd (State Route 10), New Haven, CT,

informing the public of the Company's filing of an application with the Council for a Certificate in connection with the MWR Rebuild Project and the details of the hearing for Docket No. 508 scheduled for April 28, 2022. 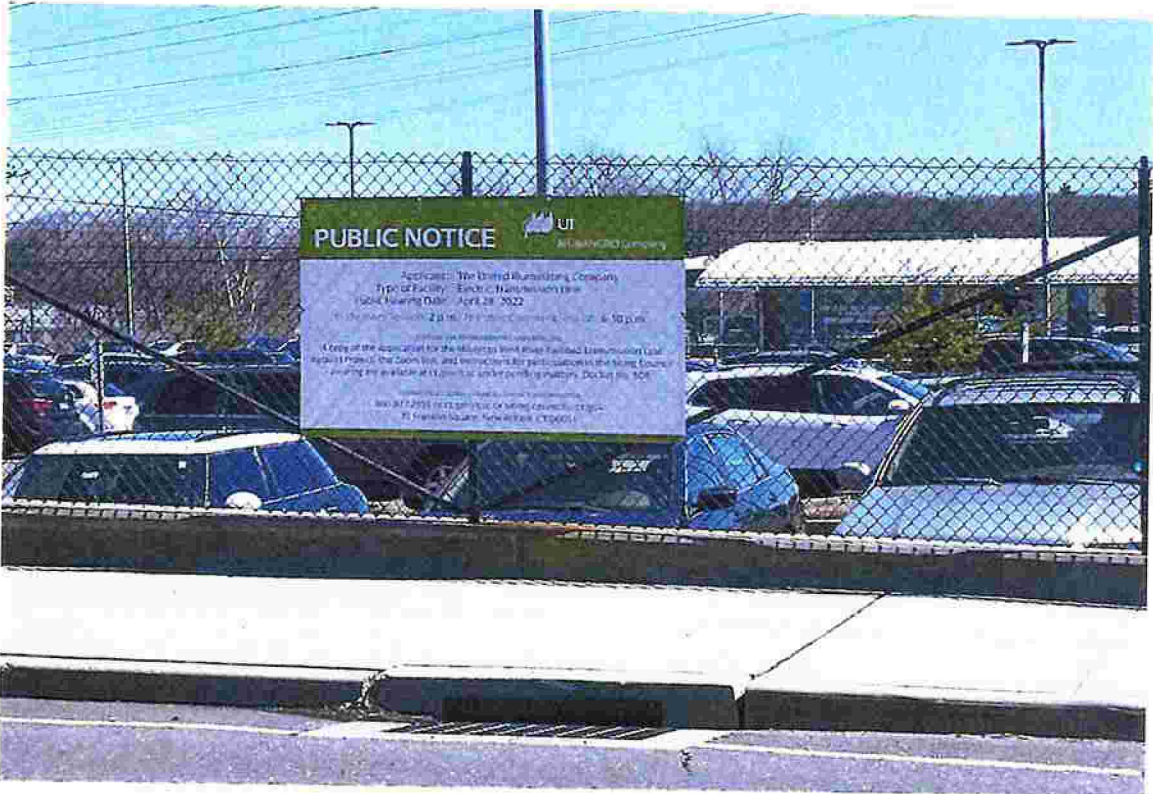

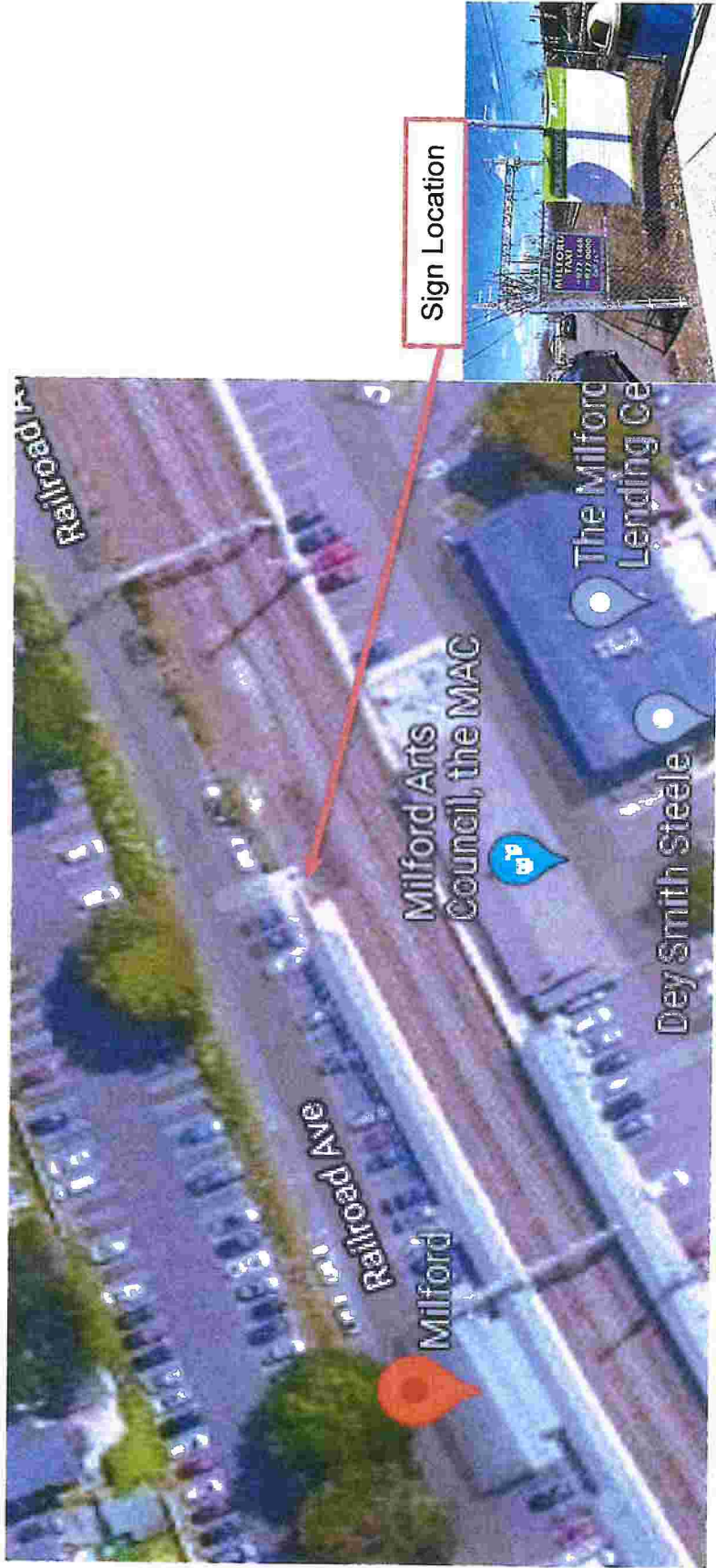

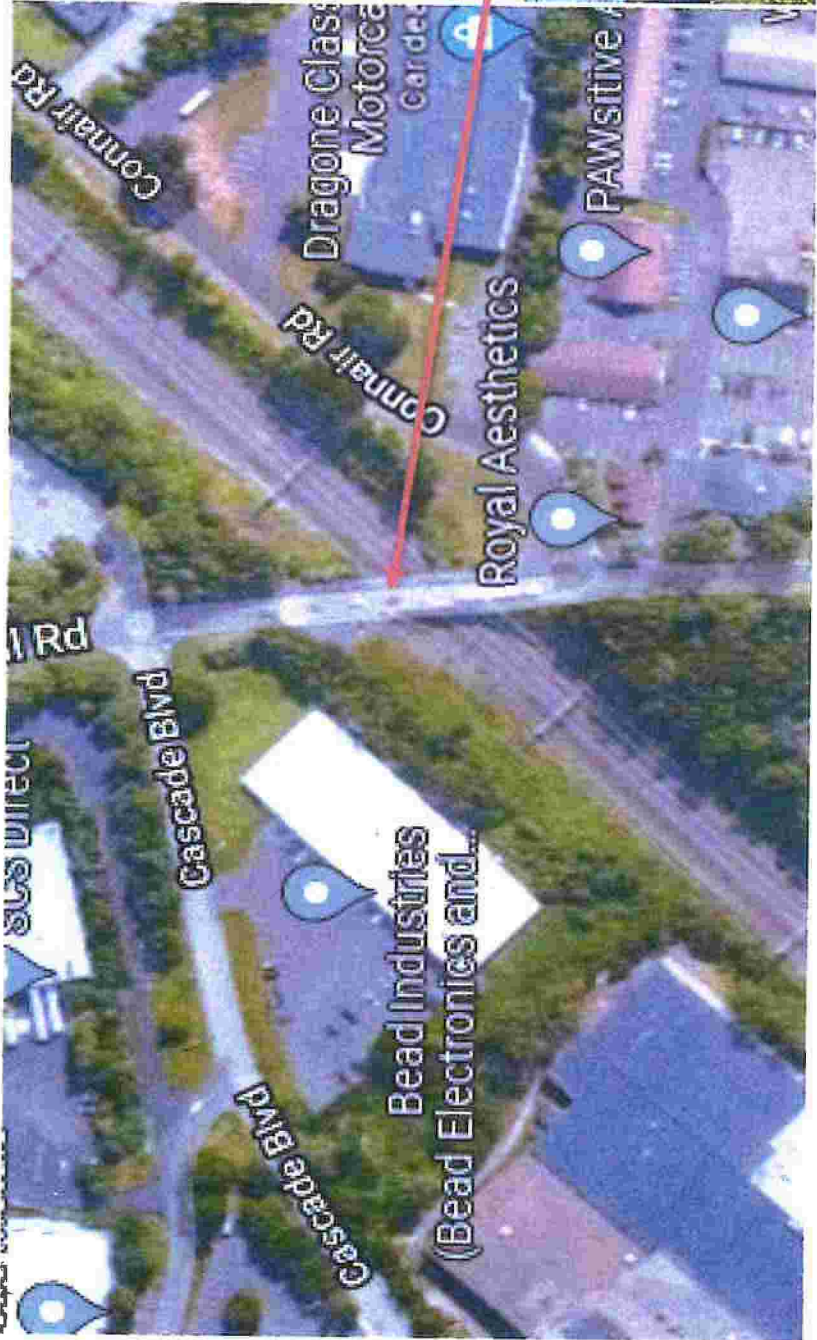
