The United Illuminating Company's Motion for Extension of Time

Pursuant to Section 16-50j-22a(b) of the Regulations of Connecticut State Agencies,¹ The United Illuminating Company ("UI" or the "Company") hereby moves the Connecticut Siting Council (the "Council") for an extension of time until June 8, 2022 to file responses to the City of Milford's third set of interrogatories, issued on May 31, 2022 to UI (the "Interrogatories"), and the late-filed exhibit requested by the Council in a memorandum dated May 25, 2022² (the "LFE"). The Interrogatories and LFE are presently due on June 7, 2022.

¹ Section 16-50j-22a(b) of the Regulations of Connecticut State Agencies, in part states that "[a]ny party or intervenor may request that the Council take any action by filing a motion which clearly states the action sought and the grounds thereof."

In the May 25, 2022 memorandum, the Council requests that UI file as a late-filed exhibit cost data for various components of the proposed project. In a similar manner, one of the Interrogatories requests that UI provide the same type of cost data for another component of the proposed project. Although UI has completed the necessary calculations to compute the requested project costs, the Company has not finished compiling copies of the reference sources that were used to make these calculations and creating maps of each of the route alternatives discussed. For this reason, to provide a thorough response and better substantiate the record, the Company needs an additional day to finish putting together the LFE and responses to the Interrogatories.

For the foregoing reasons, UI respectfully moves that the Council grant the Company's motion for an extension.
