The Facility is proposed on a 5.16-acre parcel of land owned by 1837 LLC identified as Map 23, Block 27, Lot 75 on the Town of New Canaan Tax Map and includes an approximately 5,100 square-foot lease area in the central-northwestern section of the parcel.

The Facility consists of a new self-supporting monopole designed to resemble a pine tree ("monopine") that is 110' in height with faux branches extending an additional 5' above the top of the pole, bringing the total height of the monopine to approximately 115'. The monopine tower

will be located within a 3,000 square-foot fenced equipment compound at grade level. AT&T's antennas would be installed at a centerline height of 106' on the monopine tower and the Facility will be designed to support the antennas and

equipment of other FCC licensed wireless carriers.

The proposed Facility will also be used by the Town of New Canaan for emer-

gency communications.

The Application explains the need, purpose and benefits of the Facility and also describes the environmental impacts of the proposed Facility.
