NOTICE OF INTENT TO BE A PARTY

Pursuant to Connecticut General Statutes (“C.G.S.”) Sections 4-177a and 16-50n (a), and Regulations of Connecticut State Agencies (“R.C.S.A.”) Section 16-50j -14, Jamie Buschmann, Trustee, hereby requests permission of the Siting Council (“Council”) to participate, as a party, in the application and hearing process for Docket No. 509.

Mrs. Buschmann received a copy of the above-captioned application from the applicant, Homeland Towers, LLC, pursuant to C.G.S. Section 16-50l. Section 16-50n (a) provides, in relevant part that “[p]arties to a certification or amendment proceeding or to a declaratory ruling proceeding shall include . . . “each person entitled to receive a copy of the application or resolution under section 16-50l, if such person filed with the council a notice of intent to be a party.” This petition constitutes notice to the Council that Mrs. Buschmann intends to become a party to this proceeding.


Mrs. Buschmann resides at 359 Dan's Highway New Canaan, Connecticut, which abuts the location of the tower proposed in Docket No. 509. The proposed tower will be visible from Mrs. Buschmann's residence, and if constructed, will have a significant negative effect on the value of and her enjoyment of her property. Mrs. Buschmann's interests therefore will be substantially and specifically affected by this proceeding.

Mrs. Buschmann proposes to participate in the hearing by filing pre-hearing interrogatories, cross-examining the Applicant's witnesses, and offering oral and written testimony or evidence.

For the above-stated reasons, Jamie Buschmann, Trustee, petitions the Council to participate in this docket as party.


