The following is in response to your inquiries.

Centennial Watershed State Forest consists of both Class 1 land owned by Aquarion Water Company and Class 2 land owned by DEEP, as shown on the map. DEEP also owns Class 3 land in Centennial, but there doesn't happen to be any in this area.

The original NRMA called the land the "Conservation Land", which is why the Conservation Land Committee which manages the land is so named. But the term "Conservation Land" was confusing to the public. In 2003, it was renamed "Centennial Watershed State Forest", to honor the 100<sup>th</sup> anniversary of the creation of the State Forest system (1903), and to let people know that despite part of it being owned by DEEP, it is a drinking water watershed with public access regulated by the Department of Public Health.

Thank you for the telephone call today. I appreciate your sending me the agreement relating to the creation of the Centennial Watershed State Forest.

#### Governor Rell Announces the Dedication Of Centennial Watershed State Forest

Largest open space acquisition in state history encompasses more than 15,000 acres

Governor M. Jodi Rell today announced the designation of the new Centennial Watershed State Forest, the largest open space acquisition in the state's history. The new state forest encompasses more than 15,000 acres of land the state acquired in 2002 from the Aquarion Water Company largely in Fairfield County as well as land in Litchfield, New Haven and Hartford Counties. The name was chosen in recognition of the 100-year anniversary of forest management in the State of Connecticut.

"The Centennial Watershed State Forest, in addition to being the state's largest open space acquisition, also bears the distinction of being the first new state forest designated in more than 30 years," said Governor Rell. "The Centennial Watershed State Forest pays tribute to Connecticut's commitment to the protection of the beauty and character of our state and to the contributions made by hundreds of men and women over the last hundred years who have helped shape our rich landscapes.

"Open space is a nonrenewable resource that we owe it to our children to preserve," Governor Rell added. "Every acre we can preserve is an acre for future generations to enjoy."

With the addition of the Centennial Watershed State Forest, the state forest system has grown to more than 30 state forests, totaling over 149,000 acres.

In 2002, the Department of Environmental Protection (DEP), in partnership with the Nature Conservancy, closed on the acquisition of rights to the 15,300 acres of watershed land with the Aquarion Water Company, a subsidiary of Kelda Group. The purchase price was \$90 million. The state acquired conservation

and public access easements to properties directly adjacent to reservoirs and streams and to the title to properties in close proximity to the reservoirs and throughout the watersheds. Since the acquisition, the DEP has been working with Aquarion and the Nature Conservancy to develop management plans for the different parcels.

The 15,000 acres that make up the Centennial Watershed State Forest are heavily forested with miles of pristine streams, upland ridges, and reservoir shorefront. About 90% of the new state forest is located in Fairfield County, with additional property in Litchfield, New Haven and Hartford Counties.

The property includes additions to Housatonic State Forest in Canaan, Naugatuck State Forest in Oxford and Indian Well State Park in Shelton. The acquisition includes frontage along the Saugatuck Reservoir (Redding, Easton, and Weston), the Hemlock Reservoir in Easton and Fairfield, Trap Falls Reservoir in Shelton, Lake Wagnum in Canaan, the Laurel Reservoir in Stamford and New Canaan and the Simsbury Reservoir in Simsbury. Portions of the property surround Trout Brook Valley, The Nature Conservancy's Cathedral Pines Preserve and the state's Canaan Mountain Natural Area Preserve.

The Connecticut State Forest System was created in January 1903. In that year, the state purchased 70 acres of brush land in Portland and named it Portland State Forest. The name was later changed to Meshomasic State Forest. From that first small purchase, Connecticut's State Forest system has grown to more than 30 state forests.
