Motions

During a public hearing of the Connecticut Siting Council (Council) held on July 14, 2022 the Council ruled on the following motion:

Jamie Buschmann, Trustee, Mark Buschmann, Trustee and Mark Buschmann Motion to Strike Limited Appearance Statements, or in the alternative, Motion to Compel Appearance for Cross Examination, and Request to Reply and Present Oral Argument on Council Staff's Recommended Disposition of the Motion, dated July 6, 2022.

The motion, its alternative and the request were denied.

Continuation of Evidentiary Hearing

The Council shall continue the evidentiary hearing for the above-referenced proceeding on Tuesday, August 16, 2022, via Zoom conferencing, beginning at **2:00 p.m**. A copy of the Instructions for Public Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the continued cross examination of the Applicants by the Buschmanns to be followed by cross examination of the Applicants by the New Canaan Neighbors, and continuing with cross examination of the Applicants on the late-filed exhibits by Verizon and the Council. Thereafter, the hearing will continue with the appearance of the parties and intervenors in the order listed on the hearing program for cross-examination by the Council, Applicants and other parties and intervenors.

Homeland Towers, LLC and New Cingular Wireless PCS, LLC d/b/a AT&T Late-Filed Exhibits

During the July 14, 2022 evidentiary hearing session, the Council requested that the Applicants submit the following information as late-filed exhibits:

- 1. The 24-hour rainfall rate for a 10-year storm;
- 2. The existing stormwater management features on Ponus Ridge Road;

- 3. Clarification of the number of trees to be removed on Sheet SP-2 using the tree survey information provided on Sheet EX-1;
- 4. A preliminary site construction phasing plan that includes a construction sequence/phasing, erosion/sedimentation and stormwater controls, site stabilization measures and any additional measures necessary to prevent runoff from impacting Ponus Ridge Road and the Laurel Reservoir; and
- 5. Clarification of the statement "Wetland Inspection Report included in Application Attachment 9" provided on p. 2 of the Applicants Supplemental Submission dated June 21, 2022.

The Council requests these late-filed exhibits be submitted to the Council before the close of business on **August 9, 2022**.

The final deadline for exchange of interrogatories between parties and intervenors is before the close of business on **August 2**, **2022**. The final deadline for responses to interrogatories is **August 9**, **2022**.
