Tarpon Towers II, LLC (“Tarpon”) and New Cingular Wireless PCS, LLC (“AT&T”) will be submitting an application to the Connecticut Siting Council on or about May 26, 2022, for the construction of a new telecommunications facility in the Town of Westport, Connecticut.

The proposed facility would consist of a new 124-foot monopole tower in the rear of the 1.99-acre parcel at 92 Greens Farms Road in Westport (the "Site"). The tower and equipment will be installed within a 35' x 64' fenced facility compound. Access to and from the Site will be from Greens Farms Road. Site plan drawings for the proposed facility are attached for your review. The location and other features of the proposed facility, including tower height, are subject to change under the provisions of Connecticut General Statutes §§ 16-50g, et seq. and 47 U.S.C. § 1455e.

State law provides that owners of record of property which abuts a parcel on which a facility is proposed to be located must receive notice of the submission of this application. This notice is directed to you either because you may be an abutting landowner or as a courtesy notice.
