**LEGAL NOTICE**

Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about May 26, 2022, by Tarpon Towers II, LLC ("Tarpon") and New Cingular Wireless PCS, LLC ("AT&T") (Tarpon and AT&T are hereinafter collectively referred to as the "Applicants"). The Application proposes the installation of a wireless telecommunications tower and related facility in the eastern portion of an approximately 1.99 acre parcel at 92 Greens Farms Road, Westport, Connecticut (identified as Map 6, Block 74, Lot 000 in the Town's tax records). The Applicants propose to construct a 124-foot tall monopole (maximum height not to exceed 124' with antennas) within a 35' x 64' fenced (chain link) equipment compound within a 2500 square foot leased area. Access to and from the Site will be from Greens Farms Road. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes §§ 16-50g, et seq.

On the day of the Siting Council public hearing on this proposal, the Applicants may be asked to fly a balloon at the height of the proposed tower described above, and/or the Applicants may be requested to hold a virtual site visit. The Siting Council public hearing on the Application will be held via Zoom or in the Town of Westport.
