- Q3. Provide AT&T's site acquisition request document (the "SARF") regarding AT&T determination of need for a facility in the area of the proposed site and any map indicating a search locus (such as a "search ring") that was contemporaneously generated by AT&T.
- A3. *Included in Attachment 1 is a map of AT&T's Search Ring for the proposed site. AT&T initially issued this search ring in 2013 and submitted a collocation application with Tarpon in October of 2013 (see A2). After issuing the search ring, AT&T placed this search ring/site on hold. In December of 2018, the search ring was re-issued as no new infrastructure was built in this area during the intervening 5 years.*
- Q5. When did AT&T commit to participating in a Siting Council application? Provide document of AT&T authorization to proceed.
- A5. *AT&T agreed to participate in a Siting Council application in April 2019.*
