Motions

During a public hearing of the Connecticut Siting Council (Council) held on August 9, 2022 the Council ruled on the following motion:

Applicants' Motion for Protective Order, dated August 1, 2022

The motion was granted consistent with the Council's Procedures for Filing a Protective Order and the Council's Conclusions of Law adopted in Docket 366.

Continuation of Evidentiary Hearing

The Council shall continue the evidentiary hearing for the above-referenced proceeding on Thursday, September 22, 2022, via Zoom conferencing, beginning at **2:00 p.m**. A copy of the Instructions for Public Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the continued cross examination of the Applicants by Verizon Wireless to be followed by cross examination of the Applicants by the Town of Westport and Donald Bergmann, and continuing with cross examination of the Applicants on the late-filed exhibits by the Council. Thereafter, the hearing will continue with the appearance of the parties and intervenors in the order listed on the hearing program for cross-examination by the Council, Applicants and other parties and intervenors.

Applicants' Late-Filed Exhibits

During the August 9, 2022 evidentiary hearing session, the Council requested that the Applicants submit the following information as late-filed exhibits:

- 1. Construction Drawings with detailed Erosion and Sediment Control measures, including, but not limited to, silt soxx;
- 2. Referencing the response to Council Interrogatory 48, photo 7B, what is the distance at its closest point from the proposed access drive to the fence in the background?;
- 3. Photosimulation of a monopine tower design at the proposed site;

- 4. An estimate from the local gas distribution company for extension of the gas line to the proposed site to fuel emergency backup generators;
- 5. Breakdown of total project cost between Tarpon, ATT, and Verizon
- 6. Maximum cumulative noise emissions from the operation of the backup generators at the property line; and
- 7. Design and construction perspectives to limit disturbance within the upland review area.

The Council requests these late-filed exhibits be submitted to the Council before the close of business on **September 15, 2022**.

The final deadline for exchange of interrogatories between parties and intervenors is before the close of business on **September 8, 2022**. The final deadline for responses to interrogatories is **September 15, 2022**.
