The Connecticut Siting Council (Council) is in receipt of your correspondence dated October 24, 2023, regarding the revision to the Development and Management (D&M) Plan for the above-referenced facility that was approved by the Council on April 14, 2023.

Pursuant to Regulations of Connecticut State Agencies (RCSA) §16-50j-77(b), your request to change the centerline mounting height for AT&T's antennas from 120 feet above ground level (agl) to 121 feet agl to ensure proper separation from Verizon's antennas is hereby approved.

This approval applies only to the D&M Plan revision dated October 24, 2023.

Please be advised that deviations from the Council's Decision and Order and D&M Plan approvals are enforceable under the provisions of the Connecticut General Statutes § 16-50u. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to RCSA § 16-50i-77.
