REQUEST BY DISH WIRELESS, LLC ("DISH")  
TO INTERVENE IN THIS PROCEEDING

Pursuant to Section 16-50n of the Connecticut General Statutes and Section 16-50j-15a of the Regulations of Connecticut State Agencies, DISH Wireless, LLC ("DISH") respectfully requests permission of the Connecticut Siting Council ("Council") to participate, as an intervenor, in the application and hearing process for Docket No. 511.

DISH is licensed by the Federal Communications Commission ("FCC") to construct and operate a wireless communications system in various areas of the United States of America including the State of Connecticut in order to provide cellular and personal communication services to the public. DISH has an interest in the application process to aid the Council in evaluating the public interest considerations set forth in Section 16-50g and 16-50aa of the Connecticut General Statutes. DISH has an interest in and need for a new facility in the area to provide its services in this eastern portion of the Town of Stratford.

The Council has admitted DISH as an intervenor in previous dockets and DISH proposes to participate in applications in support of the need to continue operating other facilities in the State.

For all the foregoing reasons, DISH respectfully requests that it be named an intervenor in this proceeding.
