The Connecticut Siting Council (Council) is in receipt of the request for an extension of construction time in the above-referenced matter dated May 13, 2024. Pursuant to Condition No. 9 of the Certificate issued on January 20, 2023, the Council hereby grants your request for an extension of time to complete the construction of this facility until January 20, 2025.

Pursuant to Condition Nos. 9 and 10 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.
