Dear Attorney Jackson:

The Connecticut Siting Council (Council) is in receipt of the request for an extension of construction time in the above-referenced matter dated May 10, 2024. Pursuant to Condition No. 9 of the Certificate issued on February 2, 2023, the Council hereby grants your request for an extension of time to complete the construction of this facility until August 2, 2025.

Pursuant to Condition Nos. 9 and 10 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.


Please accept this letter from Infra Towers, LLC sent on its own behalf and on that of its tenant, New Cingular Wireless PCS, LLC d/b/a "AT&T," in connection with the above-captioned Facility for which the Siting Council issued a Certificate of Environmental Compatibility and Public Need (the "Certificate").

Condition 9 of the Council's Findings of Fact, Opinion, Decision and Order (the "Decision and Order") dated February 2, 2023 required the Facility be fully constructed and providing wireless services within eighteen (18) months from the date of the mailing of the Decision and Order.

Although the Facility is fully constructed and AT&T has installed its antennas, lines and ground equipment, AT&T continues to await the installation of fiber transport to the site. Accordingly and in keeping with Condition 10 of the Decision and Order, we respectfully request an extension of an additional twelve (12) months through August 2, 2025.
