LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about February 28, 2023, by Celco Partnership d/b/a Verizon Wireless ("Celco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility in the southeast portion of an approximately 8.17-acre parcel off Mason Hill Road in Litchfield, Connecticut. Celco proposes to construct a 110-foot monopole tower within a 50' x 50' fenced compound. Access to the facility will extend from Mason Hill Road. Celco will also install equipment and battery cabinets, a propane-fueled generator and a propane fuel tank within the fenced compound. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.
