Re: The United Illuminating Company Application for a Certificate of Environmental Compatibility and Public Need for the Fairfield to Congress Railroad Transmission Line 115-kV Rebuild Project that Extends from Fairfield to Bridgeport, Connecticut

Dear Ms. Bachman:

Pursuant to Connecticut General Statutes ("CGS") §16-50/(a), The United Illuminating Company ("UI") hereby submits to the Connecticut Siting Council ("Council") an Application for a Certificate of Environmental Compatibility and Public Need ("Application") for the rebuild of approximately 7.3 miles of its existing 115-kilovolt overhead transmission lines that presently are aligned within the Connecticut Department of Transportation's ("CT DOT") Metro-North Railroad corridor in Fairfield and Bridgeport, between Catenary Structure B648S (located just east of Sasco Creek) and Ul's Congress Street Substation (located in Bridgeport), as well as two 115-kV transmission lines located within Ul's 0.23-mile existing right-of-way that extends from the CT DOT corridor in Fairfield to Ul's Ash Creek Substation in Bridgeport. The work will also include other related improvements and modifications, including those necessary to remove the existing 115-kV line connections and link the rebuilt 115-kV lines to Ul's Ash Creek, RESCO, Pequonnock and Congress Street substations, along with the Eversource Energy transmission system near the Fairfield-Westport border.
