The Grouped LLC Intervenors are submitting pre-filed testimony from Attorney Ray Rizio, an attorney specializing in land use with over three decades of experience in local municipal zoning in the municipalities affected by the application for Docket No. 516 to discuss the impact of the proposed development on the properties owned by the Grouped LLC Intervenors, as well as the Grouped LLC Intervenors. The Grouped LLC Intervenor's request a brief extension of time until November 9, 2023, to produce Atty. Rizio and the Grouped LLC Intervenor's pre-file testimony. Atty.
