Dear Siting Council,

I would like to file as an intervener for the proposed cell tower at 3 Marchant Rd in Redding CT 06896.

I am the owner of 12 and 4 Marchant Road. We operate a complete farm with vegetables, fruit trees, chickens, honey bees and horses. We are particularly concerned about the impact of the cell tower on our honey bees and the potential impact on our livestock. We are dependent on our bees to pollinate our trees and vegetables. We also expect our bee production to reduce due to the impact of the cell towers and worse the potential for our beehives to disappear due to being disoriented from the impact of the towers.

I purchased the properties with the intention of creating this full functioning farm and with the expectation that the surrounding area would be conducive to farming, with Canine College, Boy Scout Camp and New Pond Farm surrounding our property. I did not expect to contend with the negative effects of a cell tower across the street from my farm. Our intention was to have a positive impact on West Redding and the surrounding community as a farm supplying to the community. The cell tower will not help in this effort and more than likely become a detriment to my farm and the surrounding area. I have complete cell service anywhere on my 50-acre property on my

Verizon. This cell tower proposal is in no way a requirement for our community.

I formerly oppose the cell tower and the negative impact on my farm, the community and the surrounding properties. I oppose with specific knowledge that there is no problem with our current Verizon service anywhere on our farm and knowing the purpose of the tower is to serve other areas outside of West Redding.
