Dear Madam/Sir:

I, JoAnn Villamizar, own and reside at 235 Simpaug Turnpike in Redding, which property abuts the parcel on which the proposed cell tower is planned to be constructed by MCM Holdings. Accordingly I quality as an intervenor under the statute and, thus, hereby request status as such. I object to the construction of the cell tower and additional required components on this location based upon the fact that it is a scout camp site where children are participating in events continuously including overnight camping. The children cannot be watched every minute that they are on the site and the construction of the cell tower with fencing, etc. presents a situation for children to be children which may result in harm to them. This situation falls squarely within the Attractive Nuisance Doctrine as an attractive nuisance is essentially anything that can attract teens and children to a property that threatens them with harm. Understandably, the site was likely chosen for convenience as there is an existing road to the site from Simpaug Turnpike. But should lowering cost for MCM Holdings override the safety of the children. Should we really wait until something goes terribly wrong to decide that perhaps this is not the best location for a cell tower. It should be noted that even the CEO of the corporation owning the Camp Hoyt stated that he did not believe that construction of the cell tower on the site was safe at the Redding Town Meeting where a presentation was given by MCM Holding to the neighboring land owners. The Siting Committee can certainly require MCM Holdings to provide his name as I am not aware of it if further investigation is deemed necessary. There were additional objections to the location of the cell tower on the scout camp at the meeting on the basis of the cell tower being an attractive nuisance. Accordingly, for the foregoing reasons, it is respectfully requested that the application for construction of the cell tower on the proposed parcel be denied.
