some government body sometime in the future.

2. In the event that the tower cause adverse effects on the wildlife or human health, does MCM or Verizon have adequate reserves and or insurance coverage to address potential repercussions to the impacted community? Is there any financial remedy to a potential collapse of my honey bees?
3. The tower height is stated as 150 feet. What is the actual height of the tower relative to the road on Marchant and Simpaug?
4. Do you have any pictures of the balloon without tree leave coverage?
