## LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about March 13, 2024 by Tarpon Towers III LLC and Cellco Partnership d/b/a Verizon Wireless (the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility on an approximately 6.7-acre commercial parcel at 1021-1041 South Main Street in Cheshire, Connecticut. The Applicant proposes to construct a 94-foot monopole tower in the westerly portion of this parcel. Access to the facility compound will extend from South Main Street over existing paved driveways and parking areas. Cellco will install antennas and remote radio heads at the 90-foot level on the tower. Cellco will also install a radio equipment cabinet, a battery cabinet and a diesel-fueled generator within a 20' x 86' fenced compound near the base of the tower. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.
