RE: **DOCKET NO. 526** – Greenskies Clean Energy, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a 4.999-megawatt-AC solar photovoltaic electric generating facility and associated equipment located at Lantern Hill Road (Parcel No. 169-1-4), Stonington, Connecticut and associated electrical interconnection. **Completeness Review.**

I. Introduction

The application is from Greenskies Clean Energy, LLC for the construction, maintenance, and operation of a 4.999 MW solar facility in the Town of Stonington. The Town of Ledyard is within 2,500 feet of the proposed facility.

II. Technical

The application conforms to the Council's Application Guide for a Renewable Energy Facility, includes relevant maps, descriptions of the proposed facility, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. This project would not require an outside consultant.

III. Administrative Review

All service and filing requirements pursuant to Connecticut General Statutes (CGS) § 16-50l (b) have been fulfilled. Notice to the general public was published in the New London Day.

IV. Procedural

Pursuant to CGS §16-50m, the Council must schedule a public hearing not less than 30 days and no more than 150 days after receipt of an application. At least one public hearing session shall be held after 6:30 PM for the convenience of the general public. The Council must also designate a place for the deposition of the transcript. Staff recommends holding a public hearing via Zoom remote conferencing on December 12, 2024 and depositing the transcript in the Stonington Town Hall.
