

LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about January 10, 2025 by Homeland Towers and Cellco Partnership d/b/a Verizon Wireless (the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility on an approximately 6-acre parcel off Old Chester Road North in Haddam, Connecticut. The Applicant proposes to construct a 140-foot monopole tower in the northeast portion of this parcel. Access to the facility compound will extend from Saybrook Road over a new access driveway. Cellco will install antennas and remote radio heads at the 135-foot level on the tower. Cellco will also install radio equipment and battery cabinets and a diesel-fueled generator within a fenced compound near the base of the tower. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.
