Objection to September 25, 2025 Submission of Stephen and Cindyann Longobardi

Dear Attorney Bachman:

On behalf of the Homeland Towers, LLC, the Applicant in Council Docket No. 530, I write to object to the September 25, 2025 submission of Stephen and Cindyann Longobardi (the “Intervenor”) and ask that the Council disregard this submission. The Intervenor’s letter is in response to the Council’s September 18, 2025 memorandum inviting docket participants to “identify errors and inconsistencies between the draft findings and the record”. The memo goes on to state that no new information, no new evidence, and no new arguments would be considered.

In its response, however, the Intervenor reiterates arguments made during the course of the evidentiary hearing, offers new arguments in support of its opposition to the proposed tower site asks the Council to impose conditions on the Applicant that are inconsistent with the record and the Council’s Draft Findings of Fact. While the Draft Findings of Fact may be inconsistent with the Intervenor’s position, they are not inconsistent with the overwhelming evidence in the Docket No. 530 record.

For all of these reasons, the Applicant respectfully requests that the Council disregard the Intervenor’s September 25, 2025 filing and adopt the Draft Findings of Fact as presented.
