

Dear Attorney Bachman:

On June 26, 2025, the Siting Council invited parties and intervenors to file comments concerning the Draft Findings of Fact in this matter. On behalf of the Applicants, Arx Wireless Infrastructure, LLC and New Cingular Wireless PCS, LLC, we do not have any comments.

At the June 26th Siting Council meeting to consider the Draft Findings of Fact, one of the issues that was raised was whether the Applicants had reached out to the Connecticut Department of Transportation (“CDOT”) concerning the Application. The Applicants wish to point out that Finding of Fact No. 11 correctly concludes: “On January 30, 2025, Applicants provided notice to all federal, state and local officials and agencies listed in CGS §16-50I (b). (Applicants 1, Exhibit B).” CDOT was one of the state agencies who received this notice.

Further, Finding of Fact No. 38 correctly finds that the Council solicited state agencies to submit written comments regarding the proposed facility, including CDOT. And Finding of Fact No. 39 provides that no state agencies responded with comments on the Application.

Among the conditions for the issuance of a Certificate in this docket discussed by Council members is that the Applicants again reach out to CDOT to confirm that it does not object. Accordingly, I have attached a letter that I sent to CDOT today via certified mail, return receipt requested, requesting confirmation that that it does not object to the Application. With that letter, I enclosed a copy of the notice that I provided to CDOT on January 30, 2025 with a



copy of the Application. Because of the Applicants' experience with difficulty obtaining written responses from CDOT on other proposed facilities, I asked CDOT to reply by July 18, 2025, and indicated that I would assume that CDOT has no objection to the granting of the Application if I did not receive a response by that date.

I will provide an update to the Siting Council if I receive a response from CDOT, and in any event after July 18, 2025.

I have enclosed an original and fifteen (15) copies of this letter, and the attached correspondence to CDOT.

For your reference, I've attached a copy of my letter to you on that date. The Application was filed with the Connecticut Siting Council by my client, Arx Wireless Infrastructure, LLC, and New Cingular Wireless PCS, LLC. We did not hear from the Connecticut Department of Transportation ("CDOT") in response to the Application.
