

I, Michael R. Gagnon, being duly sworn, depose and state that:


1. I am over eighteen years of age and I understand the obligations of making a statement under oath.

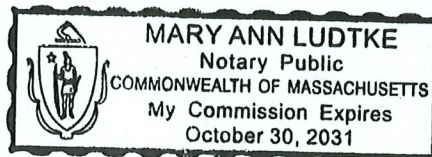

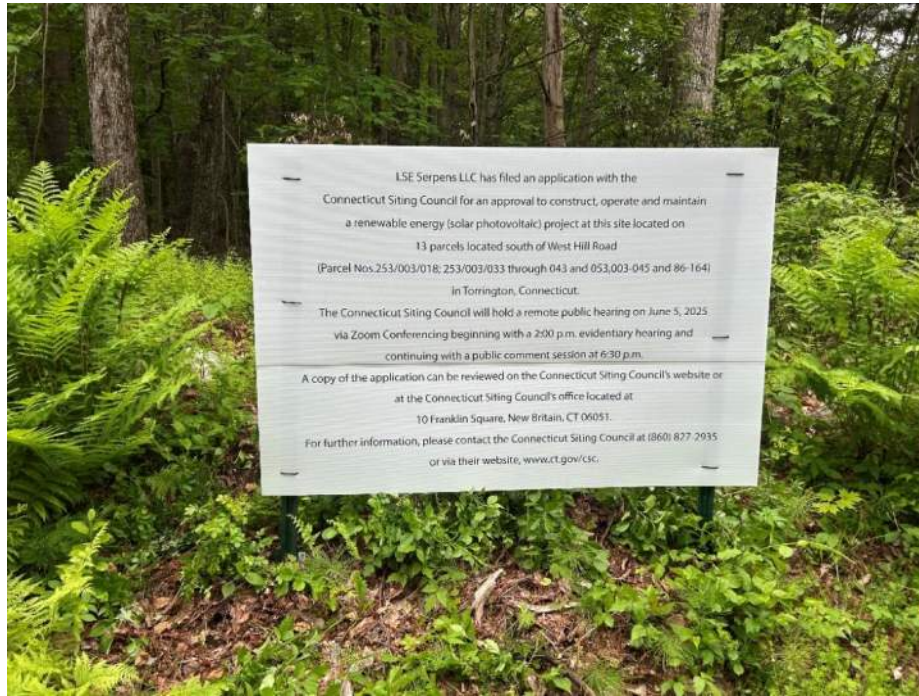


Figure 1 CSC Public Notice Sign
