Tarpon Towers III, LLC ("Tarpon") and Cellco Partnership d/b/a Verizon Wireless ("Cellco") will be submitting an application to the Connecticut Siting Council ("Council") on or about March 21, 2025, for the construction of a new telecommunications facility on a 1.74-acre parcel at 161 Conrad Street in Naugatuck, Connecticut ("Property"). Cellco identifies this facility as Naugatuck 5 CT Facility.

The proposed facility would be located in the northeast portion of the Property. At this location, Tarpon proposes to construct a 150-foot monopole tower within a 6,737 squared foot fenced compound. Cellco would install eighteen (18) panel-type antennas and ten (10) remote radio heads on a square antenna platform at the top of the tower. Radio equipment and backup battery cabinets, and a diesel-fueled backup will be located within the facility compound, near the base of the tower.

Vehicular access to the Naugatuck 5 CT Facility would extend from Conrad Street over an improved curb cut/driveway. Electric and fiber optic service would extend from existing service on Conrad Street. Site plan drawings for the proposed facility are attached for your review. The location and other features of the proposed facility, including tower height, are subject to change under the provisions of Connecticut General Statutes § 16-50g et seq. and 47 U.S.C. § 1455e.
