

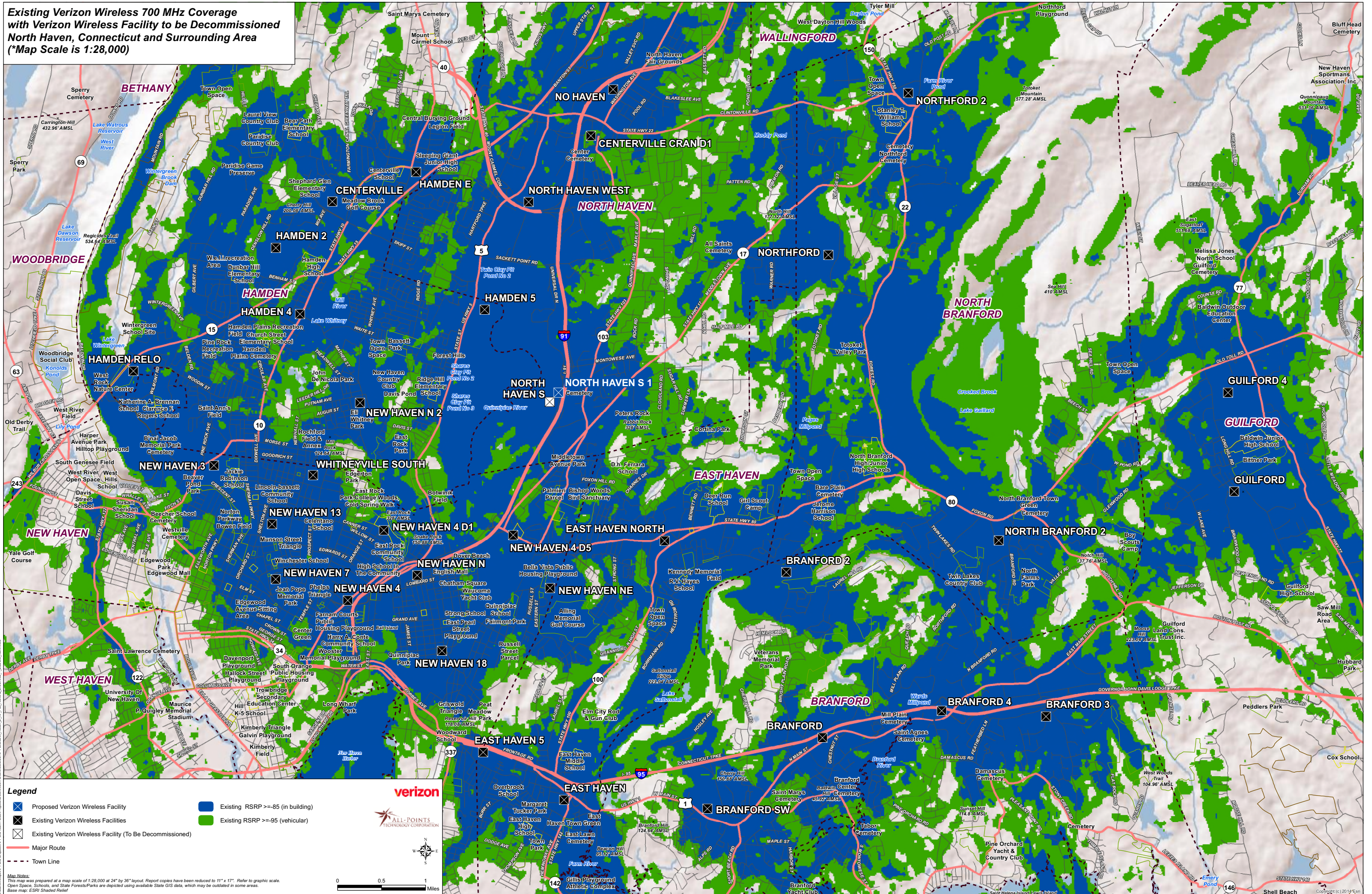

(\*Map Scale is 1:28,000)**





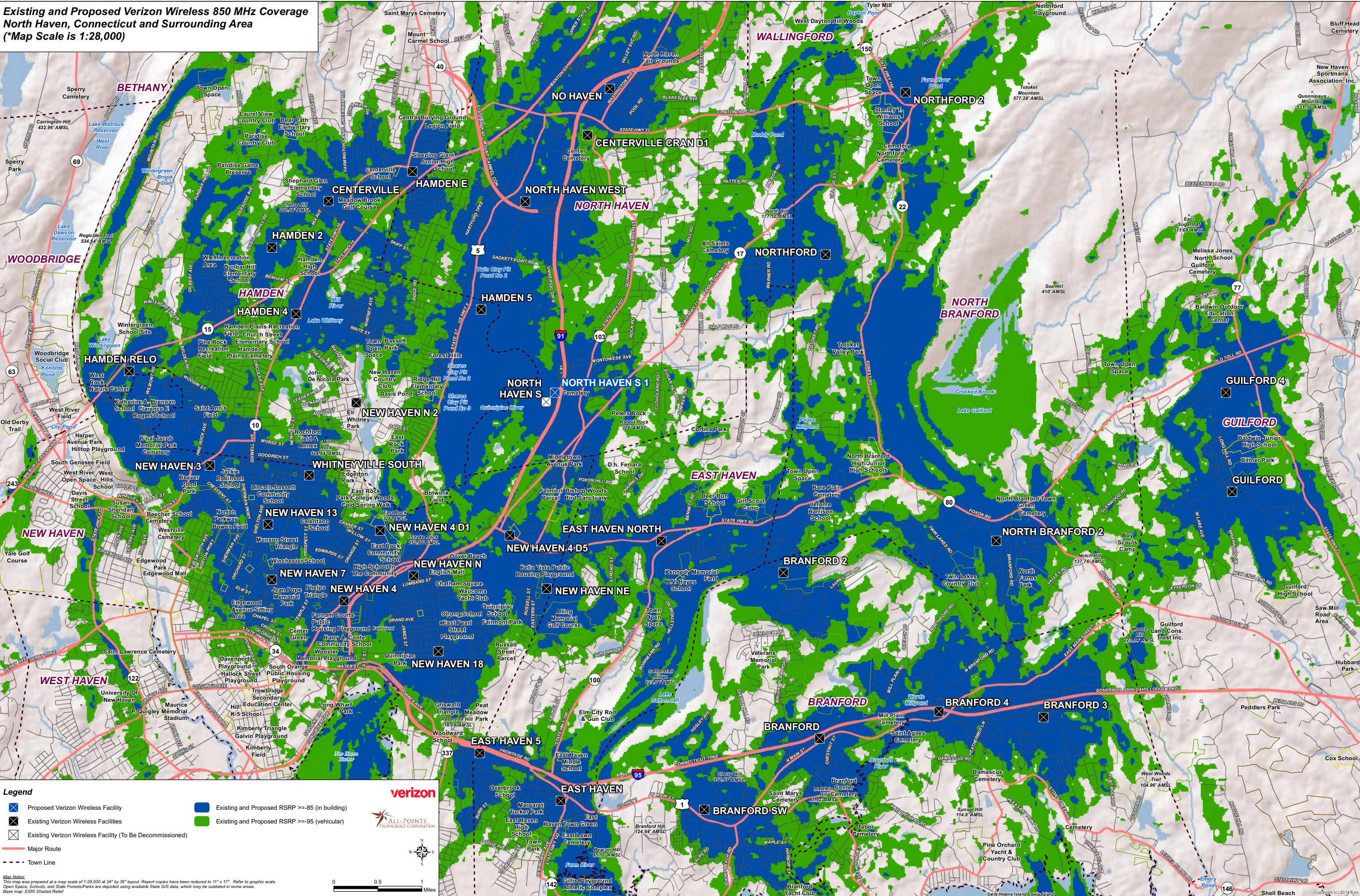






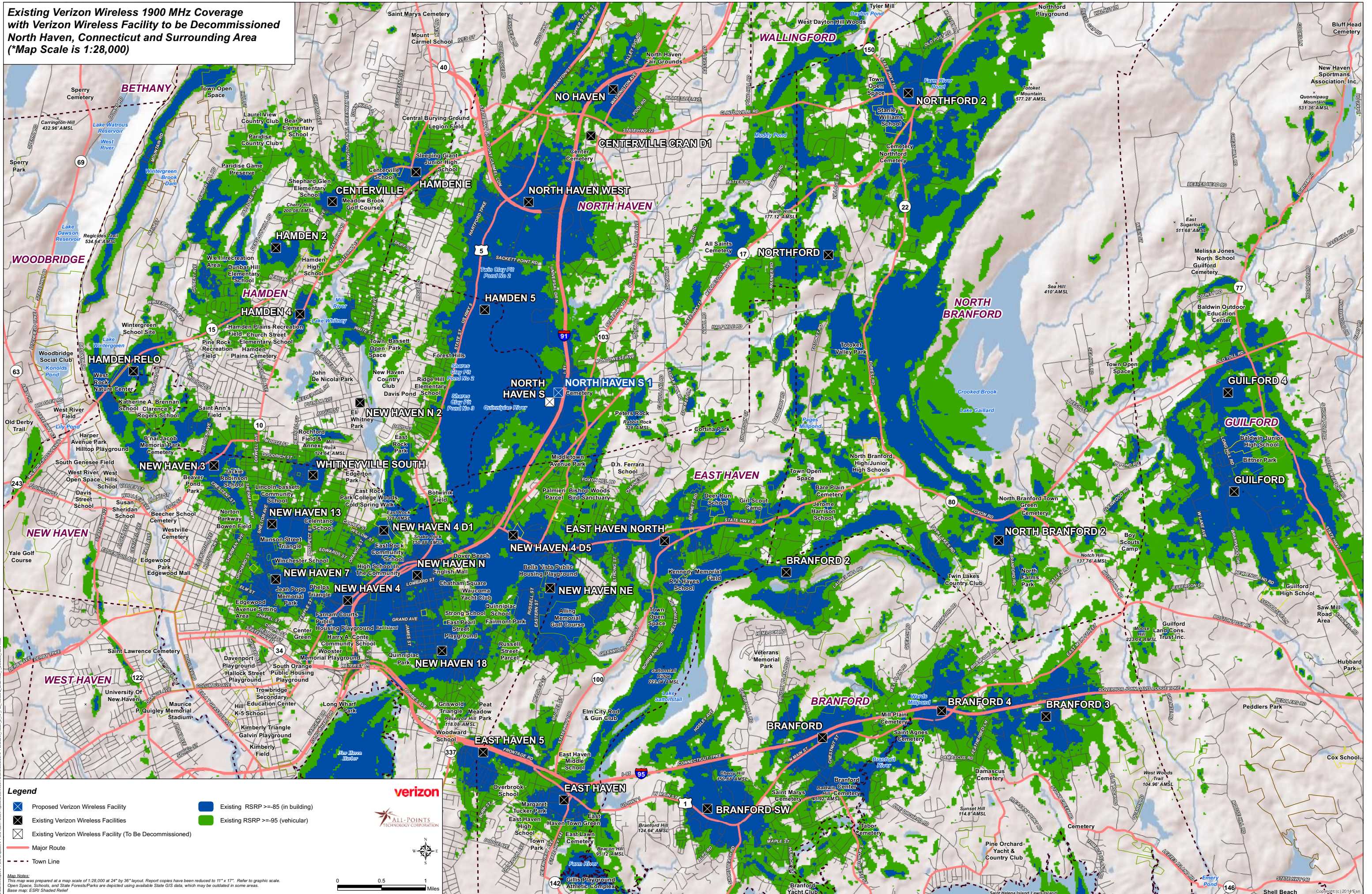


Existing and Proposed Verizon Wireless 850 MHz Coverage

(\*Map Scale is 1:28,000)



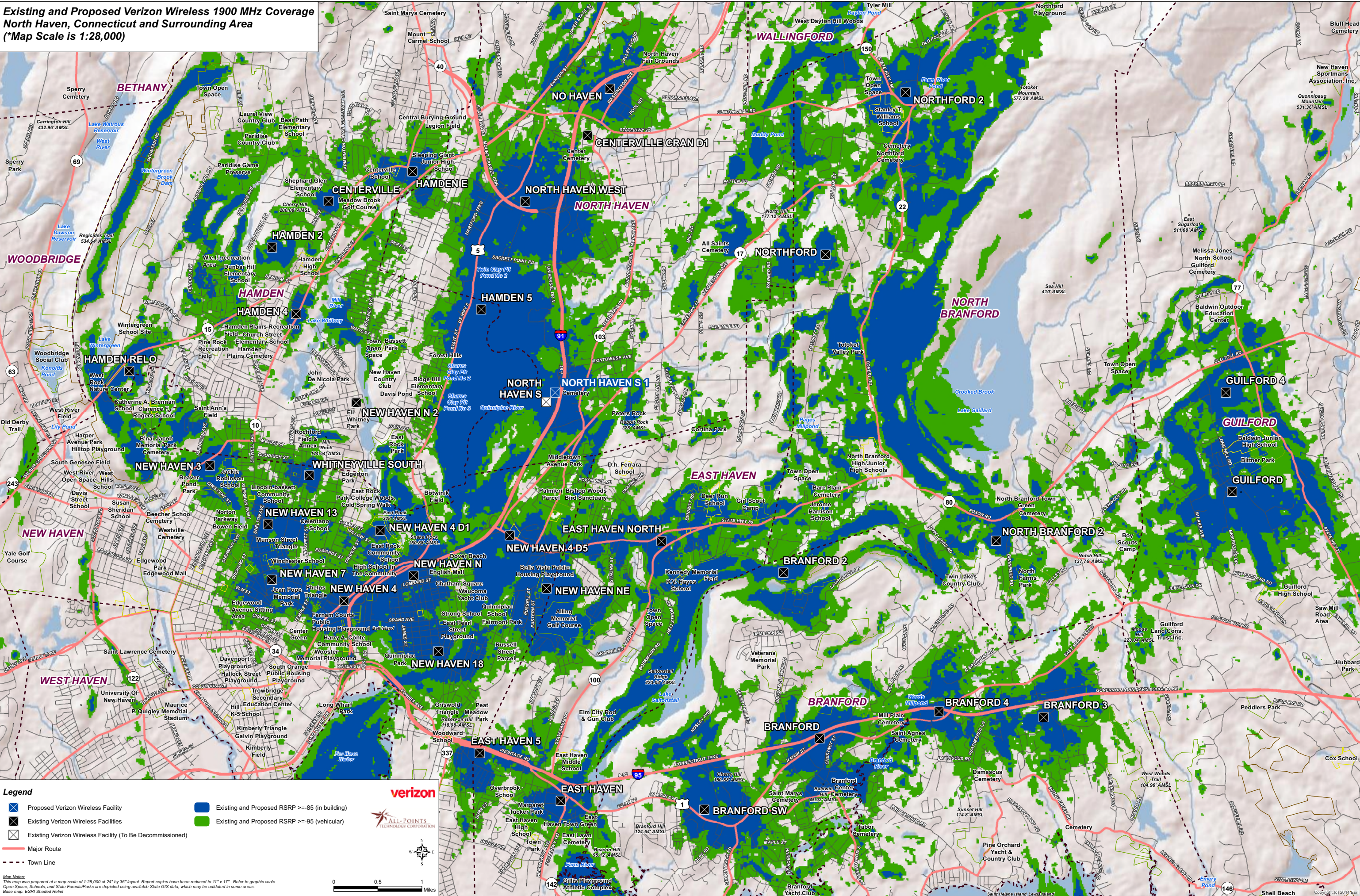


**Existing Verizon Wireless 1900 MHz Coverage

(\*Map Scale is 1:28,000)**



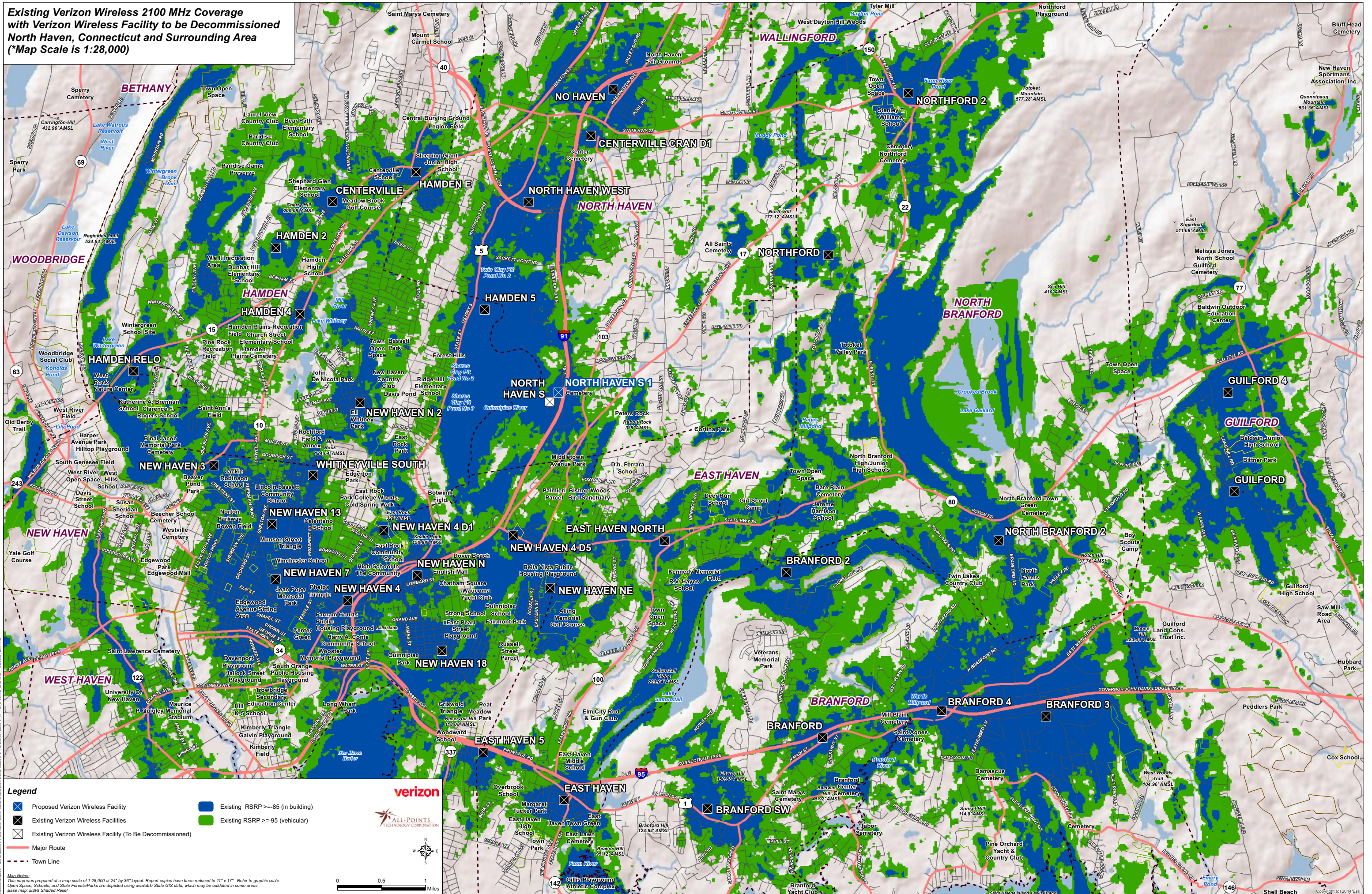


Existing and Proposed Verizon Wireless 1900 MHz Coverage

(\*Map Scale is 1:28,000)



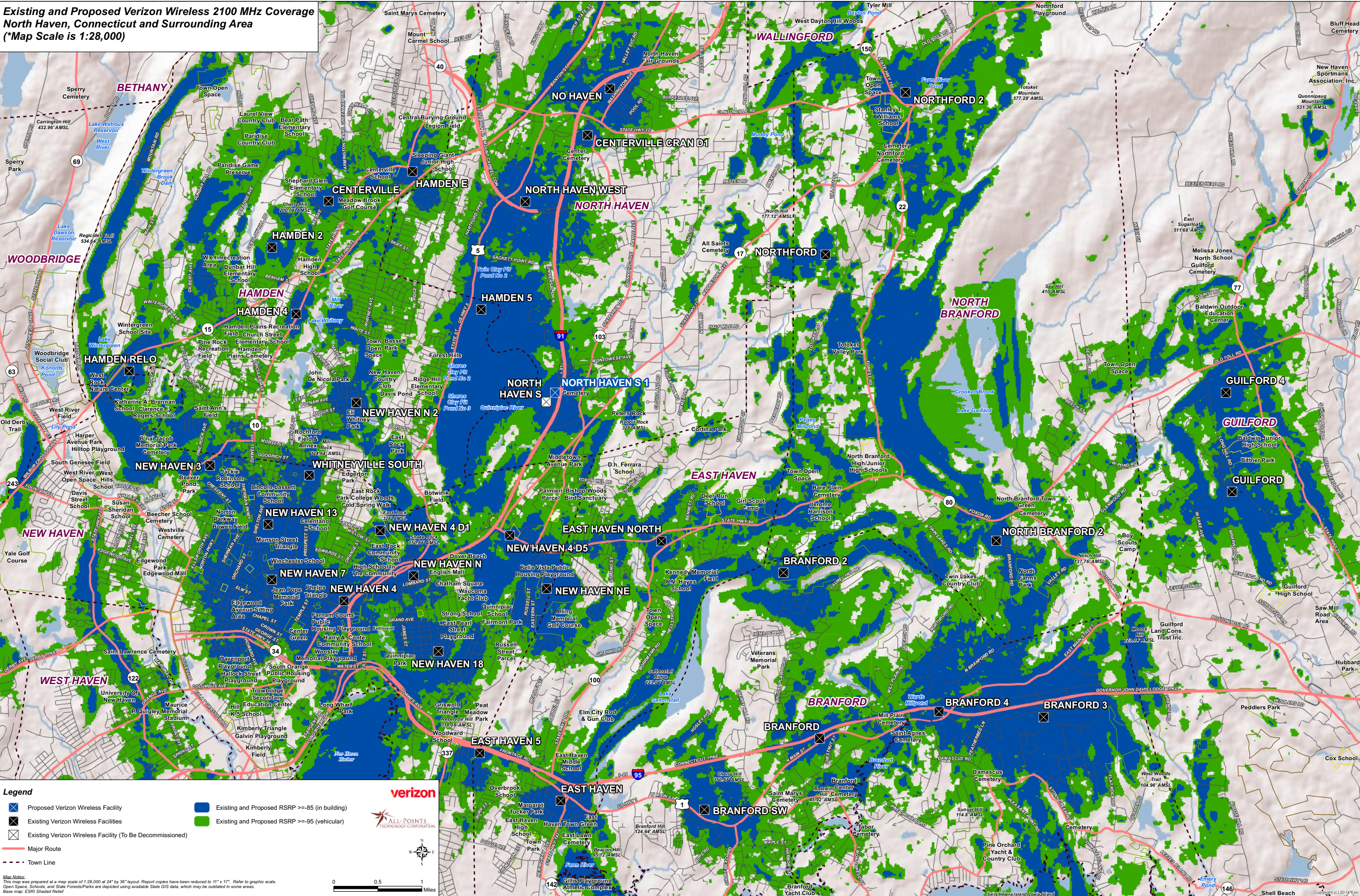


**Existing Verizon Wireless 2100 MHz Coverage
