



Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about December 11, 2025, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility in the north-east portion of an approximately 19-acre parcel, owned by Kathleen A. Holden, off Broad Brook Road in East Windsor, Connecticut (MBL# 118-36-013A and 118-36-023). Access to the facility will extend from Broad Brook Road. At this site, Cellco proposes to construct a 150-foot monopole tower, equipment and battery cabinets, a propane-fueled generator and a propane fuel tank will be located within a 59-foot by 59-foot fenced compound. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.
