## **Re:** Gravel Pit Solar – Application for Certificate of Environmental Compatibility and Public Need to The Connecticut Siting Council Regarding a Solar Project in East Windsor, Connecticut

Dear Ms. Bachman:

On behalf of the Gravel Pit Solar Project, I am submitting an Application for a Certificate of Environmental Compatibility and Public Need ("Certificate") for this Project with the Connecticut Siting Council ("Council"). This application will request the Council's approval of the location and construction of a solar photovoltaic project in East Windsor, Connecticut.

The Project includes the development of a 120-megawatt (MW) alternating current (AC) ground-mounted solar photovoltaic system. The Project will encompass approximately 485 acres (the Project Area) and will be sited on eight parcels of land totaling approximately 726 acres (the Project Site) located near Apothecaries Hall Road, Plantation Road, Wapping Road, and Windsorville Road.

With this letter, I am hand delivering two full sets of the 924-page application, two full sets of drawings, and a compact disk containing the entirety of the filing. Given the voluminous nature of the filing, it may be easier for you to access it through a file sharing service on the Project's website. If you go to <u>https://www.gravelpitsolar.com/resources</u>, you can access a full copy of the application there. The drawings for the Application (Exhibit C of the Application), is on a separate link on that website. It is my understanding that a filing fee of \$25,000 has already be delivered to the Siting Council to address administrative expenses. If that is not the case, please let me know.
