The Connecticut Siting Council (Council) is in receipt of your additional request for an extension of construction time in the above-referenced matter dated June 13, 2023. Pursuant to Condition No. 7 of the Certificate issued on May 24, 2021, the Council hereby grants your request for an extension of time to complete the construction of this facility until November 24, 2024.

Pursuant to Condition Nos. 7 and 8 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.

On May 24, 2021, the Siting Council approved the construction of the above referenced wireless telecommunications facility in Wolcott, Connecticut (Docket No. 494). Due to changes in budget priorities, construction of Cellco's Wolcott South Facility did not commence on or about March 15, 2023 as previously noted. Construction is now targeted to commence in early 2024. A more precise date is still yet to be determined. Cellco will resubmit its notice at least two weeks prior to the new commencement of construction date as soon as that information is available.

In addition, due to this unforeseen delay in construction, Cellco respectfully requests a second extension of the Council's approval for twelve (12) months, to November 24, 2024, to complete the development of this facility. Thank you in advance for your cooperation.
