To Whom It May Concern:

I write on behalf of Tarpon Towers II, LLC ("Tarpon"). Tarpon intends to file with the Connecticut Siting Council ("Council") an application for a Certificate of Environmental Compatibility and Public Need ("Application"). The Application will address a proposed installation of a monopole wireless telecommunications facility ("Facility") to be located at 800 Prospect Hill Road, Windsor, Connecticut ("Property").

The Facility would host an antenna array belonging to T-Mobile Northeast LLC, a subsidiary of T-Mobile USA Inc. d.b.a. T-Mobile. The Facility would consist of a new monopole structure with related equipment placed nearby within a 2,500 (50 x 50) square foot fenced compound located in the northern portion of the Property. Access to the Facility would be across an existing bituminous drive.

This letter serves as notice to you as an abutting property owner pursuant to § 16-50*l* of the Connecticut General Statutes. Tarpon will file the Application on or about November 13, 2020, and a public hearing will be held in accordance with General Statutes § 16-50m.
