**PETITION TO INTERVENE**

In accordance with General Statutes § 16-50n and § 16-50j-15 of the Regulations of Connecticut State Agencies, T-Mobile Northeast LLC, (“T-Mobile”), respectfully seeks to be designated as an intervenor in the above-captioned Docket concerning an application by Tarpon Towers II, LLC (“Tarpon”). T-Mobile’s participation as an intervenor shall furnish assistance to the Connecticut Siting Council (“Council”) in resolving the issues in the proceeding, is in the interests of justice and will not impair the orderly conduct of the proceedings. Regs., Conn. State Agencies, § 16-50j-15(d); General Statutes § 4-177a.

**I. Petitioner Contact Information**

T-Mobile is a wireless provider licensed by the Federal Communications Commission. T-Mobile has a business address of 12920 SE 38<sup>th</sup> Street, Bellevue, Washington, 98006. Communications concerning this matter can be directed to the undersigned.

**II. Basis For Intervenor Status**

T-Mobile is the anchor tenant on the proposed telecommunications facility (“Facility”). As set forth in Tarpon’s Application, the proposed Facility is an integral component of T-Mobile

wireless network in the subject area of the Town of Windsor (“Town”). (*Application, p. 5; Attachment 5.*) The proposed Facility is necessary for T-Mobile, in conjunction with other existing telecommunications facilities within the Town and surrounding areas, to provide reliable services to the public.

Through witness testimony, along with the written submissions associated with Tarpon’s Application, T-Mobile can offer specifics about its wireless network, the important role the proposed Facility would play in that network, and its expertise and experience as a wireless provider in Connecticut. T-Mobile has also participated in numerous other proceedings before the Council. Ultimately, T-Mobile’s participation in this proceeding would aid the Council in determining whether a public need exists in accordance with General Statutes §§ 16-50g, 16-50p as well as the Telecommunications Act of 1996 and the various rulings of the FCC concerning the need to ensure the rapid deployment of and universal access to wireless services.

WHEREFORE, T-Mobile respectfully requests permission to participate in the above-captioned Docket as an intervenor.
