Dear Ms. Bachman:

I am writing on behalf of my client, Burlington Solar One, LLC, in connection with the above-referenced Docket, specifically Conditions 4 and 5 of the Council's Decision and Order in this matter. Pursuant to Condition 4, Burlington Solar One, LLC is providing the Council with a copy of the General Permit for the Discharge of Stormwater and Dewatering Wastewaters from Construction Activities that was issued by the Connecticut Department of Energy and Environmental Protection to Burlington Solar One, LLC on September 9, 2021. This permit was the only remaining state or federal permit the project needed to obtain prior to construction.

The project has now received all permits necessary for construction. Accordingly, the project intends to begin construction as soon as it receives approval of its Development & Management Plan ("D&M Plan"). Should the project's D&M Plan be placed on the Council's agenda for the Council meeting scheduled to occur on September 23, 2021, and should the Council approve the project's D&M Plan at that meeting, this letter will serve as two weeks' notice that the project intends to start construction on September 27, 2021, in accordance with Condition 5. Should the project not be placed on the agenda for the September 23rd meeting, or should the project not receive approval for its D&M Plan at that meeting, this letter will serve as confirmation that project construction will not begin until the Council provides such approval.
